The current path to \$15 as proposed would be a major victory for tens of thousands of RI workers and their families, ensuring they can better afford housing, healthcare, and other needs.

I believe that increasing the hourly minimum wage will help workers increase their quality of life as well as increase the contributions they can make to our economy. It will also show our fellow neighbors that they are appreciated, respected, and valued members of society.

The pandemic has made it clear that essential workers don't just work in hospitals. They work to serve other neighbors in establishments like grocery and retail stores, hotels, restaurants, cafeterias, schools, and everyone's beloved Dunkin'.

My younger brother lives with a serious mental illness and depends on a support network to stay healthy. His support network consists of his family, and the Newport Mental Health Center (NMHC.) He depends on Medicare to pay for his medications and appointments. Through the NMHC, he was able to secure an apartment and a job in a cafeteria at the Naval Station in Newport. He earns an hourly wage above the current minimum wage but would greatly benefit from an increase in wages. He is just one of many RI residents whose life would be improved by an increase in the minimum wage.

I also ask that you strengthen the legislation to increase the minimum wage for tipped workers to \$15 as well. In addition to H-5130, I also support a provision that will ensure the minimum wage will be increased to meet the demands of inflation.

My name is Maeve Wiesen, and I am writing in support of H-5130. I am a resident of Providence and I am also the Political Director of the College Democrats of Rhode Island.

Rhode Islanders deserve a living wage- right now, people who work full time jobs may still be struggling to pay their bills and survive. This is simply unacceptable. We need to increase the minimum wage to \$15/hour, and we need to do it quickly. An increase too gradual won't help people who are struggling right now. If someone is working hard in their job, they deserve to be financially stable, and that is true for everyone ranging from business owners to people working service jobs. The pandemic has shown just how essential people working jobs at grocery stores and restaurants are. The passage of H-5130 is a critical way to support these people.

Additionally, we need to include tipped workers and domestic workers in the increase. Servers deserve a living wage, and they should not be at the mercy of tips in order to do so. I think we are all familiar with circumstances where someone refused to tip a server because of something out of their control, like the food coming late, or because the customer decided the server did not have a nice attitude. Leaving servers at the mercy of people who do not know their lives and stories is cruel. Including tipped workers and domestic workers in the increase is critical if we want to support all Rhode Islanders with this critical legislation.

Finally, we need to tie minimum wage to inflation. As cost of living goes up, so should the wages that people make. Otherwise, we are leaving thousands of people in this state behind.

As a young person, I often hear people say that minimum wage is designed for high schoolers making pocket money- this could not be further from the truth. People support families and children with a minimum wage salary, and pretending that this isn't the reality is ignorant of real life circumstances.

Thank you for your work, and I hope you will vote favorably on H-5130.
