IN GENERAL ASSEMBLY.

January Session, A.D. 1902.

AN ACT

to incorporate La Salle Academy.

It is enacted by the General Assembly as follows:

Section 1. Mathew Harkins, Thomas F. Doran, Thomas P. Grace, Thomas L. Kelley, Patrick Farrelly, Joseph R. Bourgeois, James E. Sullivan, John T. Maguire, James T. Egan and John B.A. Tangway, their associates and successors are hereby made a corporation by the name of La Salle Academy for the purpose of maintaining an academy of learning for educational, literary and scientific purposes, with all the powers and privileges and subject to all the duties and liabilities set forth in Chapter 177 of the General Laws, and in any acts in amendment thereof or in addition thereto.

Sec. 2. Said corporation may ^{by} buy, devise, or otherwise, take, hold transmit and convey real and personal estate to an amount not exceeding the sum of two hundred thousand dollars.

Sec. 3. Said corporation shall be located in the city of Providence, state of Rhode Island.

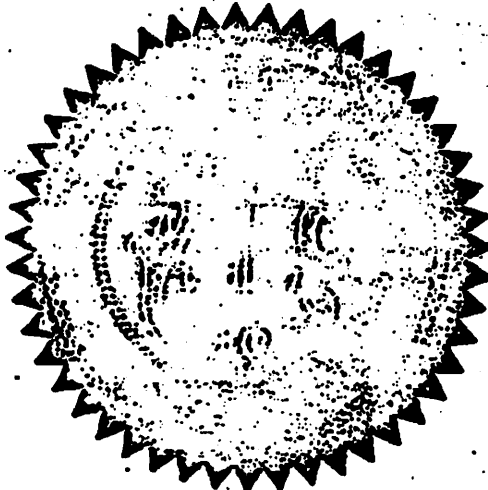

IN GENERAL ASSEMBLY.

January Session, A. D. 1910.

AN ACT

In amendment of an act, entitled "An act to incorporate LaSalle Academy" passed at the January Session of the General Assembly, A. D. 1902.

It is enacted by the General Assembly as follows:

Section 1. Section 2 of an act, entitled "An act to incorporate La Salle Academy," passed at the January Session of the General Assembly, A. D. 1902, is hereby amended so as to read as follows:

"Sec. 2. The object of said corporation shall be to disseminate a broad, complete and liberal education in the arts and sciences, and to afford youth the advantages and opportunities of a liberal education, whercin their moral, religious, civic and intellectual duties and responsibilities are clearly set forth and emphasized; and said corporation is hereby empowered to establish and maintain within this state a college for the education of youth, and for that purpose to erect and maintain suitable buildings, employ proper teachers and assistants, confer all the learned degrees which are usually conferred by any of the colleges in New England upon proper qualification, and do and exercise any and every other power proper to carry into effect the objects of this act."

Sec. 2. Section 3 of said act is hereby amended so as to read as follows:

"Sec. 3. Said corporation may receive and acquire by gift, devise, bequest, purchase, or otherwise, and may hold, manage and dispose of real and personal estate, and the income thereof, to an amount not exceeding five hundred thousand dollars, which shall be exempt from taxation; provided, however, that the real estate to be exempt hereunder shall be occupied and used for the immediate purposes of said corporation, and all the real and personal property heretofore or hereafter given, devised, bequeathed, granted or as-

signed, to said corporation, or for its use, and the income thereof, shall be held and employed for the uses and trusts, if any, expressed in the instrument or instruments under which the same was acquired, provided such uses and trusts are not repugnant to the laws of the state."

Sec. 3. Section 4 of said act is hereby amended so as to read as follows:

"Sec. 4. Said corporators and their associates and successors shall have the entire management and control of the affairs of said corporation; shall determine the times and places of meetings; shall by election fill all vacancies which may from time to time occur in their body and shall have full power from time to time to elect such officers as they shall deem necessary or convenient, remove the same, fix the terms of their respective offices, and adopt such regulations and by-laws as they may deem proper for the government of said corporation and college not repugnant to the laws of the state."

Sec. 4. This act shall take effect upon its passage.

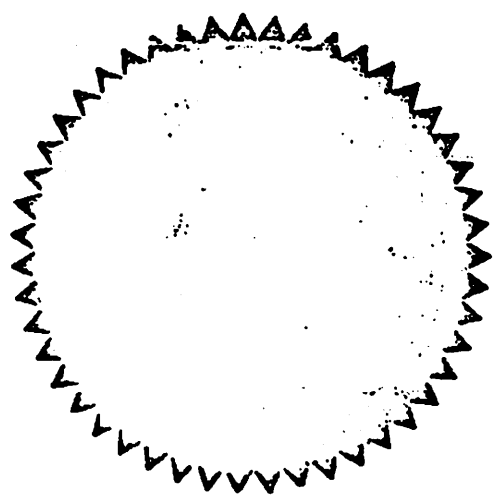

AN ACT IN AMENDMENT OF AN ACT ENTITLED "AN ACT EXEMPTING FROM TAXATION PROPERTY OF THE WOONSOCKET, R. I. YOUNG MEN'S CHRISTIAN ASSOCIATION."

H 788
Approved
April 27, 1925.

It is enacted by the General Assembly as follows:

SECTION 1. Section 1 of an act entitled "An Act exempting from taxation property of the Woonsocket, R. I. Young Men's Christian Association" passed at the January session, A. D. 1910, is hereby amended to read as follows:—

"Section 1. The real and personal property of the Woonsocket, R. I., Young Men's Christian Association, a corporation created under the provisions of the general laws of the state, shall be exempt from taxation to an amount not exceeding two hundred fifty thousand dollars, as long as such property shall be used for the purposes of said association."

SEC. 2. This act shall take effect upon its passage.

AN ACT IN AMENDMENT OF AN ACT, ENTITLED "AN ACT TO INCORPORATE LA SALLE ACADEMY," PASSED AT THE JANUARY SESSION, A. D. 1902, AS AMENDED BY AN ACT PASSED AT THE JANUARY SESSION, A. D. 1910, AMENDING SAID ACT TO INCORPORATE LA SALLE ACADEMY.

It is enacted by the General Assembly as follows:

SECTION 1. Section 2 of an act, entitled "An act to incorporate La Salle Academy," passed at the January session, A. D. 1902, as amended by an act, passed at the January session, A. D. 1910, amending said act to incorporate La Salle Academy and renumbering said section as section 3, is hereby further amended so as to read as follows:



"Sec. 3. Such corporation may receive and acquire by gift, devise, bequest, purchase or otherwise and may hold, manage and dispose of real and personal estate in an amount not to exceed three million dollars, and said property shall be exempt from taxation in so far as the same shall be used exclusively for educational purposes."

SEC. 2. This act shall take effect upon its passage.

AN ACT TO VALIDATE THE ACTS OF EDGAR E. MILLER AS A
NOTARY PUBLIC.

It is enacted by the General Assembly as follows:

SECTION 1. All acts, matters and things done or performed by Edgar E. Miller, of Cranston, as a notary public in the state of Rhode Island, appointed by the governor, but not duly engaged, between June 30th, 1923 and January 31st, 1924, are hereby declared valid and effectual in all respects as if the said Edgar E. Miller had taken the engagement and filed the certificate prescribed by the laws of the state before entering upon the duties of said office, provided the same shall not affect any pending litigation.

SEC. 2. This act shall take effect upon its passage.

This responds to your July 23, 2020, request for information regarding the status of your group tax exemption.

Our records indicate that you were issued a determination letter in March 1946, that you are currently exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, and are not a private foundation within the meaning of section 509(a) of the Code because you are described in sections 509(a)(1) and 170(b)(1)(A)(i).

With your request, you provided a copy of the *Official Catholic Directory for 2020*, which includes the names and addresses of the agencies and instrumentalities and the educational, charitable, and religious institutions operated by the Roman Catholic Church in the United States, its territories, and possessions that are subordinate organizations under your group tax exemption. Your request indicated that each subordinate organization is a non-profit organization, that no part of the net earnings thereof inures to the benefit of any individual, and that no substantial part of their activities is for promotion of legislation. You have further represented that none of your subordinate organizations is a private foundation under section 509(a), although all subordinates do not all share the same sub-classification under section 509(a). Based on your representations, the subordinate organizations in the *Official Catholic Directory for 2020* are recognized as exempt under section 501(c)(3) of the Code under GEN 0928.

Donors may deduct contributions to you and your subordinate organizations as provided in section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to them or for their use are deductible for federal estate and gifts tax purposes if they meet the applicable provisions of section 2055, 2106, and 2522 of the Code.

Subordinate organizations under a group exemption do not receive individual exemption letters. Subordinate organizations are not listed in Tax Exempt Organization Search (Pub 78 data), and many are not listed in the Exempt Organizations Business Master

File extract, or EO BMF. Donors may verify that a subordinate organization is included in your group exemption by consulting the *Official Catholic Directory*, the official subordinate listing approved by you, or by contacting you directly. IRS does not verify the inclusion of subordinate organizations under your group exemption. See IRS Publication 4573, *Group Exemption*, for additional information about group exemptions.

Each subordinate organization covered in a group exemption should have its own EIN. Each subordinate organization must use its own EIN, not the EIN of the central organization, in all filings with IRS.

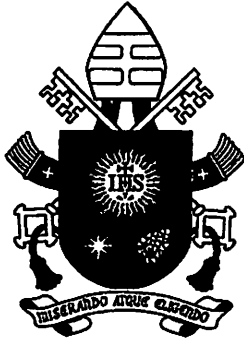

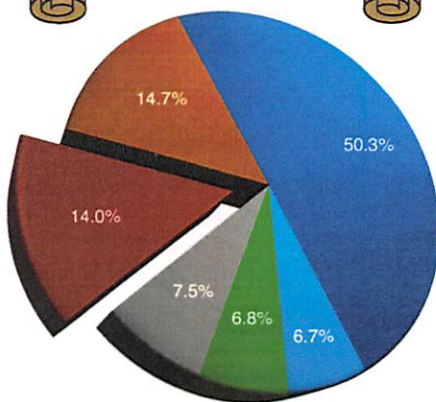

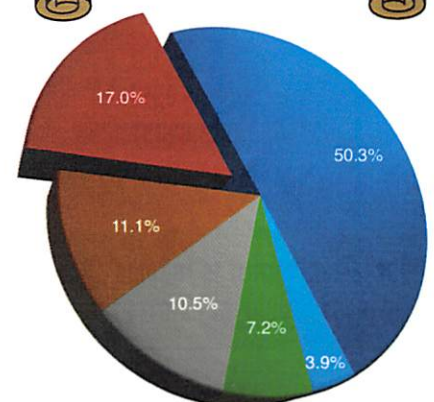
