As a native Rhode Islander, State of RI health care worker, and a mother of two, I would like to weigh in on how the American Rescue Plan money should be spent.

I am an RN at the RI Veterans home and I worked through the entire epidemic. I could have filed for unemployment as they were allowing parents with kids home "distance learning" to do, but I chose not to. I could have requested the hotel vouchers to stay in a hotel as not to risk infecting my family but I did not. I instead constructed a decontamination room in my garage and was meticulous about removing my clothes, disinfecting my hands, and heading directly to the shower. I slept separately from my husband for many months until he decided he would rather accept the risk than have me sleeping on an air mattress in the living room any longer.

As the daily briefings from Governor Raimondo and Dr. Alexander Scott heightened the alarm and heeded everyone to stay home, I watched from work in full PPE while caring for scared Veterans isolated in their rooms and from their family. As the vigorous Covid testing ensued- initially nasopharyngeal which are very unpleasant, so did the mandatory overtime. Many employees started testing positive and therefore had to stay home and quarantine for 2 weeks. The mandates to stay and work and additional 8 hours began and were brutal at times. I came to work on a daily basis not knowing if I would return home until midnight. Wearing an N95 mask for 16 hours and having to work at minimum staffing levels and meet the needs of 16 residents all isolated in their rooms was onerous. My family and household suffered with me. All this while many Rhode Islanders were paid and extra \$600 to stay safely in the comforts of their home. To add insult to injury the powers that be

ignored Article 10 in our UNAP contract that provides compensation at the rate of time and half for working during the declaration or a State of Emergency. Many state workers worked virtually from home or isolated in their offices at no extra risk, this was not the case for myself and coworkers in health care but no differentiation was made.

At one point during the pandemic our facility was at critical staffing levels and FEMA deployed nursing staff to come the RI Veterans home. They were compensated generously by the government to do the job we had been doing and continued to do when their term ended at the Vets home. Even the travel agency nurses that the Veterans home contracts for extra nurses and CNAs were receiving a Covid stipend.

To Summarize I am in favor of some sort of Recognition Pay for all of the Health care workers and essential workers that did not have the luxury of working from home via Zoom or other internet avenues. I think it would be a great thing for the moral of the essential workers who knew that **showing up** was just as important as **staying home** for some of us during this pandemic.

How can the money be spent to bolster education and RI businesses and attract investment and business from beyond our borders? The spending plan should be long-term at its core. What can we do now to insure a thriving, trained/educated population 10 or 20 years from now? The politicians mulling over these funds need first to have a vision of a future Rhode Island and not exhaust the funds by handing them out willy-nilly to their constituents.

A program of this magnitude needs to become long range, ongoing and institutionalized in order to make any impact. The message that passenger cars on the road for every short trip for shopping, banking, and grocery errands is a major factor in build up of greenhouse gases in the atmosphere needs to be held by a majority of citizens.

Current lifestyle choices and the proliferation of drive-up windows over the last two decades are not sustainable.

## Good afternoon!

I am a mother of a special needs daughter, age 12 who is currently in the Bradley Hospital. Stuck between having the home supports and residential placement. Due to lack of staffing issues, turnover's and a decent compensation.

The level of work it takes to support care in human service far exceeds the wages, mandatory overtime and working conditions,

(Don't know how many people can take a punch in the face for a child with behavioral issues)

My daughter (Ava) has had a 7 year cycle of in and out of the hospital. She is now institutionalized; think about all the insurance claims from Ambulance services, ER's, hospital stays and treatment center's alone could have paid higher salaries for preventative care/services.

\*\*Service's where hard to keep even before the Pandemic.

My daughter was eligible for many services that never happened, due to lack of staff.

This year, I had to advocate/fight for a treatment that is showing positive results....

My daughter, is doing ECT(Electro Convulsive Therapy) which is helping with her mood, access to other parts of her brain (talking more, focus, an interest in learning and most of all overall happiness. However Bradley Hospital is not in compliance with my daughter's IEP-Individual Education Plan/(free appropriate public education-FAPE.

How is my daughter supposed to thrive? The treatments are allowing her to be more compliant and focused.... So she can wait on services that she is entitled too.

What about no child left behind? IEP? HBTS-(home based therapeutic services)?


The IEP is a legal document, not being followed. Currently, as we are in the hospital so much, we don't even have an out of district school placement. Note: The Town of Johnston is working on a Tutor.

I am trying to advocate for a better system in the mental health crisis and for human services. "the other pandemic"

I have tried to work with Life Span about adding a step down program, like the Rite House and The Craft Program for the CADD (Center of Autism and Developmental Disability) unit.

The Rite House and The Craft Program have higher rates of success. The reason for success in these programs is to have the child in a more natural environment and the level's of control decrease gradually. My daughter goes from a psychiatric treatment center, (Bradley) to home, school and HBTS.

My daughter 7 year cycle below and many others have proven this cycle is not effective. This costs more money with insurance claims, a lot of waiting and loss of my daughter's childhood. This is what a broken system looks like:



Here are is what it costs when a child goes into the hospital: for 30 days to camp out/wait for treatment. Base Rates \$\$\$\$ one day:

Step down program's have an 80% to 85% rate of success. The child getting the support they need quicker. Getting home services in place quicker and school placement.

This is just one child one admission.

I have sent numerous emails to ask for help in this crisis to all the senators, governor, my state representative and many other groups/organizations.

I need help to make my voice heard.

I spoke with one of the clinician with one of the programs listed:

He states, "Skill acquisition is much higher, a success rate is much higher for the child to placed appropriately" Data is tracked and used to have the child safely back in the home or Residential's" "At the end of my day I feel that we identify lots of strategies for families to use" "We as clinicians get to see the journey of a child having impactful opportunities"

This is what needs to be fixed:

## My examples:

(I am sure you are aware that it's just like using an emergency room for a primary care)
Our kiddos fill up emergency rooms, medical beds, residential's and treatment facilities like Butler and
Bradley. This backs up the system and forces kids to have more wait times for care. Waiting for a psychiatric

treatment bed is torture for kids and parents. Think about E/I-(Early Invention) has such a waiting system, the kids are going to age out before necessary services can help them. Children are our Future!

\*Having appropriate supports in place before a crisis happens would be more cost effective for everyone.

I bring this up as an example to prove that our state can act quickly:

During the pandemic the state was able to immediately open over flow hospital's, testing centers and places for vaccinations (ASAP) Why can't this type of response be used to help this mental health crisis?

\*\*home supports we're impossible to keep even before the pandemic.

I am working with some mom advocate's and Tina Spears-CPNRI.

We need The American Rescue Funds to help raise wages for workers in the human service field.

We need all girls youth Residential's. Staffed and ready.

We need our kids in state for Residential's and all care.

We need a step down program for the Bradley CADD Unit.

We need center's based and home based supports for Children and Adults with disabilities. Remembering our population of kids require structure even during school breaks, holidays and summertime.

We need access to qualified employees that have access to a competitive salary with benefits for the job they do.

Lastly, I am working with Paul LaCava and mom advocate's to try to layer in more supports for children and adults in behavioral issues. Think about the flexibility for a CNA worker with a Milieu experience. Something like a teaching hospital so field work would be part of their degree.

Also adding a certificate for speech therapy assistant. How about creating across the board Milieu training as a certificate program? Think how that would help so many home supports including Early Intervention. To entice workers, have sign on bonuses, relief staff - can fill in on a minutes notice (paid at a higher rate) or per diem staff.

Let's have higher education that justifies increases in salaries. Room to grow.

We need, Teamwork with other agencies like (Trudeau, Seven Hills, and Groden) working with DCYF, so we can save money, have prevention measures in place for behavioral health and eliminate out of state placements.

I have proposed a lot of idea's and my goal is help the mental health crisis and human services field become better.
