Dear chair and committee members;

Bill 2023 H5688 is a barely veiled attack on teachers and fact based learning. It's an obvious attempt at creating a loophole for religions to be as intrusive as it wants in regards to a child's education. This bill is purposely creating a spot in learning for ideas that don't correspond or are in direct conflict with facts and reality. There's a lot of troubling parts of this bill that should raise alarms with any sensible person. But representing Rhode Island Atheists I'm going over the religious implications.

As parents we're responsible for the way our children learn to navigate our complicated world. Every good parent wants their children to grow up to be honest and productive adults. Capable of also carrying on our family values and traditions. Whether they're cultural or religious, those are the most personal

parts of us. And we want to leave them for the next generation.

Those stories, traditions and values that specific families subscribe to is taught at home. Not at a public school. Religious dogma cannot be allowed to dictate academics. They're separate for good reasons. When superstitious beliefs aren't allowed to be challenged. We end up having witch trials, inquisitions and religious oppression championed by the religion with the most power. Not with the most truth.

The country we live in today came out of the realization that progress isn't possible when faith is the motivation.

This bill would also allow a racist parent to stop their child from learning anything that contradicts their beliefs. No matter how wrong or disgusting they may be. It would allow ignorance to go unchallenged

and stop the open exchange of ideas. It's a religious abuse of our system. To use the public schools to help make their job of indoctrination easier. And that can't be allowed. Children also have a right to the best fact-based learning experience we can provide for them. That's how we prepare them for adulthood. But if your main concern is the fear that your children may learn how to think critically you're already violating their rights as individuals. It's denying them the information they deserve to make their own decisions on how and what they believe.

What would my life look like now if my mother was able to force teachers into withholding any facts that challenged her beliefs?
