This bill outlines a comprehensive process that mandates public school districts and the department of elementary and secondary education to adhere to specific procedures when considering the closure, phase-out, or merger of a public school. This includes announcing proposals, providing detailed reports on facility conditions and enrollment trends, and

developing contingency transition plans for students, families, and staff affected by these decisions.

One of the most significant aspects of the bill is the requirement for public engagement and community input throughout the decision-making process. It mandates that the powers that be hold multiple meetings and forums with stakeholders, including staff, students, families, and community members, to share information, gather feedback, and address concerns regarding proposed closures or mergers. This ensures that the voices of those directly impacted by these decisions are heard and considered before any final determinations are made.
