

February 5, 2024 **In Support** of RI House Bill 7295
To the RI House Committee on Environment and Natural Resources:

My name is Jennifer Sherman, and I support H 7295.

I was fortunate to be a member of the RI Geoengineering Study Commission, whose work documents the phenomenon of manmade weather modification, with a long history of governmental and private funding. Intertwined with the international military interests, academia and private industry, it involves the deployment of what constitutes weaponry upon us, The People.

On the bright side, this year we don't have to go through the arduous process of proving this is happening, specifically that Solar Radiation Modification (SRM) is a real thing. The White House document you are now all in possession of clearly spells out what is going on. It also lays bare the idea that the Federal Government is still unsure how to govern as it conducts "experiments" over and through all of us who never consented to be participants.

I use the word "through" here because absorbed metals, like the ones mentioned in [CONGRESSIONALLY MANDATED RESEARCH PLAN AND AN INITIAL RESEARCH GOVERNANCE FRAMEWORK RELATED TO SOLAR RADIATION MODIFICATION of June 2023](#) make all living beings more conductive and therefore more susceptible to the effects of manmade microwave radiation pollution, which is also deployed for weather modification. This speaks to enormous suffering for people and animals, alike.

This is where The State of Rhode Island is obligated to step in. There should be no confusion about governance because The Constitution of the United States of America and the Rhode Island Constitution are pretty clear. The challenge has been to get the state, via elected, obviously party obligated politicians to enact governance to protect their constituents, the environment and the valuable natural resources of our state.

I have Multiple Sclerosis (MS) and a compromised immune system. I am disgusted by the "held for further study" announcements made BEFORE testimony was given - not just last year but the year before as well. Two years worth of committee meetings on this subject wasting everyone's time. There is literally nothing left to study! This year The White House is telling us exactly what they have been funding and plan to do.

Metals that produce neurological malfunction are deliberately being released in absorbable forms upon the population, and upon every other living thing. I never consented to this poisoning and I am sure most rational people wouldn't, either. The question then becomes who exactly makes the final call of culling the population? Why is this not a crime? Who exactly benefits? I know I don't. I'm suffering and it's frustrating to watch the elected in both parties not step up and do what they were sworn-in to do.

This year it should be easy. It's about Pollution, Governance and Consent. H 7295 is the appropriate remedy. If it's not perfect don't hold it for further study - just fix it and pass it into law already. This is the best bill yet. It addresses very concisely what is happening and how to handle it.

Little Rhode Island has always been a leader. We didn't sign The Constitution until it had a Bill of Rights. We need to make it known that OUR STATE DOES NOT CONSENT to this Federal display of hubris. DC needs to be reminded: Just because you can do something, doesn't mean you should.
