My name is William Losefsky and this testimony is in support of H 7295.

I am a retired law enforcement officer and upon retiring I became a Corporate Security and Environmental Health and Safety Director for several large hospital systems, as well as a private investigator. I also have advanced education in Industrial Hygiene management. This unique background has provided me the skills of a lifelong and articulate skilled investigator with a keen scrutiny for details.

Moreover, I have protected our most valuable resource, our citizens for my entire career and adult life. I am now looking for you, our honorable representatives of Rhode Island to protect our citizens with the wisdom and power you possess.

Please help us cease and desist the pollution of our atmosphere by prohibiting the intentional release of polluting emissions, including cloud seeding, weather modification, excessive electromagnetic radio frequency, and microwave radiation pollution and making penalties for violations of such prohibition.
