RE: H 7358 An Act Relating to Fish and Wildlife – Deer Hunting

Dear Chairman Bennett,

Thank you for providing the Department of Environmental Management (DEM) the opportunity to comment on H 7358, which was introduced on DEM's behalf and would amend current law relating to vehicle collisions with deer. DEM supports this legislation.

The amendments proposed in H 7358 would broaden reporting requirements from strictly applying to deer to instead apply to any accident involving wildlife that substantially damages a vehicle. This ensures that accidents involving large wildlife such as turkey or bear, in addition to deer, are reported to DEM. Data from these reports is used to inform statistical models used by wildlife biologists employed at DEM to estimate the population of these wildlife in Rhode Island. Ensuring that fatalities occurring due to collisions with vehicles are accounted for is an important component of the data used in these models.

The amendments also strike language specifically requiring that accidents be reported to a conservation officer and instead provide flexibility by stating that reports must be made to DEM. DEM's intent, if this legislation is enacted, is to establish an online reporting portal along with a designated phone number that individuals may report collisions to. This change ensures that Environmental Police Officers with the DEM Division of Law Enforcement and wildlife biologists and other staff with the DEM Division of Fish and Wildlife have access to the relevant information and can share resources responding to collisions.

Finally, the bill proposes to strike language that only allows the owner of the vehicle involved in a collision, along with their immediate family, to possess and consume the animal and replaces this language with an authorization for DEM to promulgate regulations governing how the

carcasses of animals involved in vehicular collisions may be possessed and used. The intent of this change is to allow other individuals and organizations to take possession of, and use, the carcass of the animal. The regulations would set a clear, predictable process for how interested individuals and organizations can be notified by DEM of an animal that is available to be taken due to a collision.
