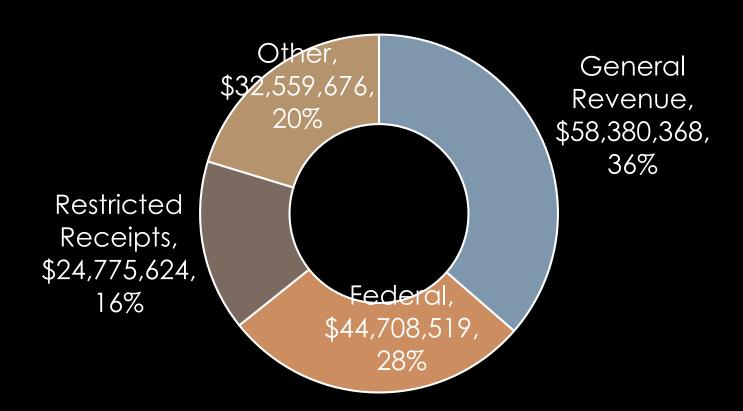

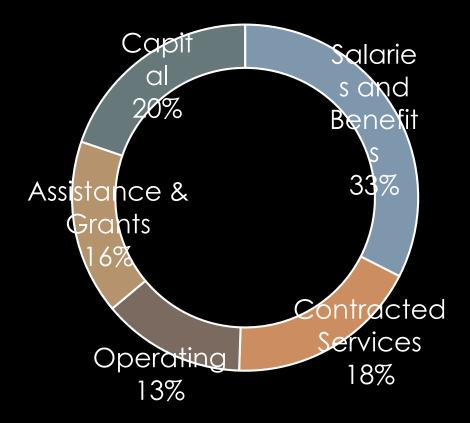

Governor's FY 2026 Recommendation

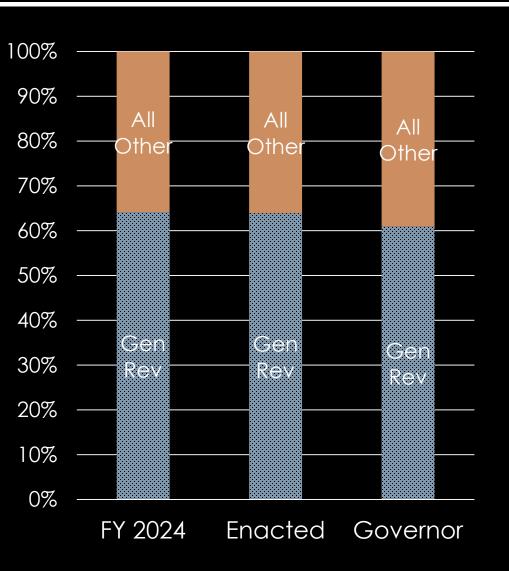


Federal Grants

 - Animal health and behavior
- FY 2026 = \$45M

- Additional turnover
- GR savings from shifting to RR & federal funds

 - Down from 64%

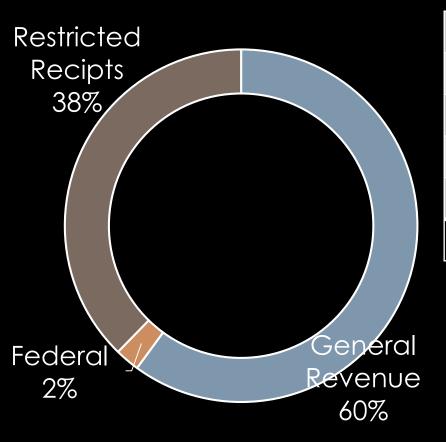

LITTER REMOVAL

- \$100,000 from general revenues
 - Began in 2022
 - Funds mostly used for grants to municipalities and organizations
 - For litter clean-ups
 - Same as enacted

ENVIRONMENTAL JUSTICE

- New federal EPA grant
 - Funding will go to The Nature Conservancy
 - Climate change issues
 - Reconnect marine & coastal systems
 - Advance science
 - Build partnerships
- \$0.3 million for FY 2025& FY 2026

ARTICLE 1 GRANTS

- General revenue support
- As enacted
 - Conservation Districts -\$180,000
 - Increased by \$80K last year
 - Wildlife Clinic of RI- \$100,000

BAYS, RIVERS & WATERSHEDS

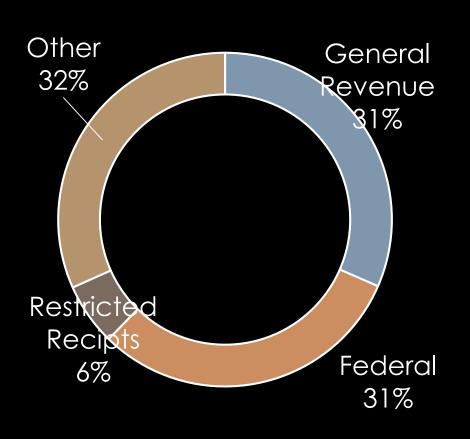
- \$0.5M from RR
 - Watershed & marine monitoring
 - Water pollution abatement
 - Climate change
- From \$1 per hundred-gallon charge on septage disposal
- Gov shifts \$0.1M of GR staffing costs to Fund
 - Will end FY 2025 w/ \$1.1M balance

- Foundry Headquarters Lease
 - 10 year lease effective July 2016
 - Current lease is set to expire in FY 2026
 - Lease costs \$2.6 million annually
 - 300 workstations/staff and 126,184 square feet
- Governor adds \$31.0 million from Rhode Island
 Capital Plan funds for FY 2026
 - Acquire & renovate 115 Tripps Lane in E.P.
 - Offset costs by terminating state leases
- DEM would move at end of lease

- Protects, manages, and restores the state's wide array of historic parks, beaches, recreational facilities, and green spaces
 - Nine divisions
 - Agriculture
 - Coastal Resources
 - Law Enforcement
 - Forestry
 - Fish and Wildlife
 - Parks and Recreation

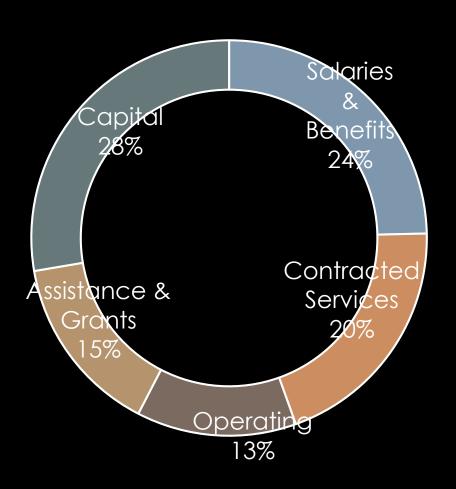

PARKS AND RECREATION

- \$22.9M & 67 FTE
 - \$16.7M from GR
- Operates & maintains campgrounds, parks & beaches
 - Recruiting seasonal staff has been a challenge for years
 - DEM must rely on contracted janitorial & security services

ENFORCEMENT

- \$8.8M & 33 FTE
 - \$4.9M from GR
- 24-hour water patrols
- Enforces laws & regs
 - Marine safety
 - Recreational fishing & hunting
- Environmental Police
 - 2024 Assembly moved state public safety to local public safety retirement benefits

SEAFOOD MARKETING

- \$100K from GR
 - Same as enacted
- Supports contracted seafood marketing specialist
 - Promotion & marketing to increase awareness & demand for local seafood
 - Emphasis on undervalued species

LOCAL AGRICULTURE & SEAFOOD GRANTS

- \$500K from GR
 - Same as enacted
- Grants to local agriculture & food businesses
 - Supports growth, development & marketing of local food & seafood

CHAFEE VESSEL REPAIRS

- New \$150K GR
 - For each FY 2025 & FY 2026
- Repairs to John H.
 Chafee research boat
 - Conducts surveys on finfish and crustaceans
 - Built in 2002
 - Needs ~\$300K in repairs

MARINE MAMMAL RESPONSE

- \$150K GR
 - State match to federal funds
 - Same as enacted
 - Supports rescue & rehabilitation of marine mammals that become stranded in RI waters
 - Two contracts for emergency response & marine mammal research

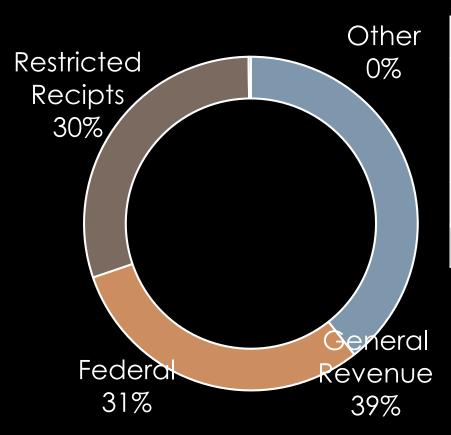
- Host Beach Communities
 - DEM collects fees for daily & seasonal parking at seven facilities across the state
 - Reimburses four host communities 27% of all daily parking fees from Memorial Day to Labor Day
 - Charlestown, Westerly, Narragansett & South Kingstown
 - 2021 Assembly authorized DEM to increase fees at Westerly state facilities
 - Governor recommends \$0.7 million
 - \$46,581 less than enacted based on FY 2025 collections

- Responsible for preventing and minimizing pollution to environmental resources
- Monitors the quality and oversees the restoration of water, air, and land
 - Six offices
 - Water Resources
 - Air Resources
 - Waste Management
 - Emergency Response

- Compliance & Inspection
- Customer & Technical Assistance

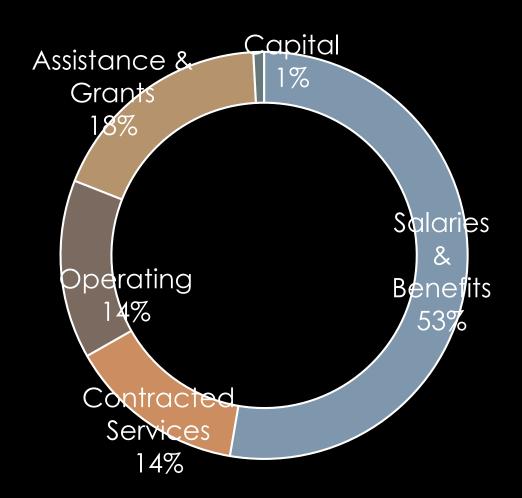

- OSPAR Oil Spill Prevention,
 Administration & Response Fund
 - Receipts from \$0.05 per barrel fee on petroleum products
 - Respond to & remediate oil spills
 - Maintain emergency readiness through responder training & equipment acquisition
 - Claims not covered by responsible parties or federal government
 - Governor shifts \$1.7M of GR staffing costs to Fund in FY 2025
 - Would leave a \$2.9M balance

- Underground Storage Tank Trust Fund
 - Created in 1994
 - 1 cent per gallon motor fuel sold to owners or operators of UST
 - Amended in 2009, one-half cent for UST
 - \$8.0 million cap on fee collection
- Eligible uses
 - Reimbursement of claims
 - Property or natural resource damage
 - DEM costs for investigation, remediation, & corrective actions

H 5075 – UST Transfer (2/25 Hearing)

- Article 1, Section 7 requires transfer of \$3.0 million from the UST fund by June 30, 2025
 - Fund has an operating surplus
 - \$1.2M FY 2024, ending balance of \$6.1 million
 - FY 2025 balance estimated at \$2.6M after transfer
 - 2024 Assembly authorized \$2.0M transfer
 - Transfers of \$2.0 million to general fund in FY 2006 and FY 2008

- Environmental Response Fund
 - \$1.7 million more than enacted
 - Reflects plan for 24 contaminated sites
 - Also supported by Underground Storage Tank Trust Fund
 - Supported by hazardous waste transport violation fees, and any settlements or penalties allowed under Rhode Island General Law
- Governor shifts \$0.5M in GR personnel costs to Fund in FY 2025
 - Would leave balance of \$14.1M

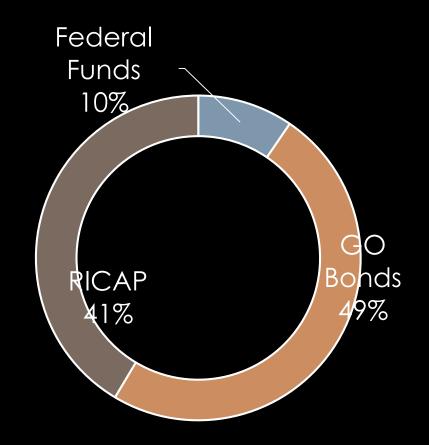

Capital Development Plan

- Governor recommends \$414.0 million for 25 projects
 - \$179.0 million between
 FY 2026 and FY 2030
 - RICAP Revisions
 - Galilee Piers
 - \$1.7M more
 - Marine Infrastructure
 - \$350K more



Capital Development Plan

- \$79 million of RICAP in 5-year plan
 - Galilee Piers \$35.1 million
 - Renovate & repair northern bulkhead, commercial fishing docks, marine infrastructure, utilities
 - Recreational Facilities \$14.7 million
 - State parks, beaches, campgrounds
 - Dam Repairs \$16.5 million
 - Natural Resources Offices & Visitors Center -\$3.7 million
 - Construct a new facility that meets code & accessibility standards

RICAP - Dam Repair

- Repairs to "high hazard" state owned dams at various recreational and management areas operated by DEM
 - Often take several years to complete
 - Dependent on seasonal conditions
- Last year, the Assembly approved \$11.5 million more than prior approvals
 - Funding maintained in Governor's current capital proposal with some timing changes
 - \$5.5 million in FY 2025

Article 3, Secs. 5 & 6 – Paint Recycling (2/25 Hearing)

- Article 3 ends program & fee collection
 - DEM would have to approve any proposed program expenditures after August 1, 2025
 - Representative org shall submit a wind-down plan to DEM by September 30, 2025
 - Plan shall include a financial audit as of 8/1/25
 - Approval required by DEM in consultation with DOR
 - Remaining funds to Resource Recovery Corp.
 - For public education regarding changes and options for safely disposing of paint
