My name is Emily Franceschi and I am a Teacher at Dr. Daycare Cumberland.

I am 24 years old. This field is where I feel my heart is. I love nothing more than watching these children learn and grow. Seeing them reach their developmental goals makes the long days worth it. Seeing their faces light up when they see me means the world. I am here for the children. Knowing I am making a difference in their lives is a feeling I wish to share. Working with kids takes a special person, and this is a field you need to be so incredibly passionate about. This is what I was meant to do.

This WAGE\$ program has been excellent and has helped me out so much. I bring home roughly \$545 weekly if I work forty hours weekly. Once my bills and other financial obligations are resolved, I'm left with little to nothing at the end of each week. I live alone with my boyfriend, so my bills include rent, car insurance, car payments, electricity, etc. I am virtually living paycheck to paycheck, which causes me extreme stress, as emergencies can always arise. I babysit occasionally and as a way to earn some extra money, but not often enough to help me begin to save money. I am also contemplating donating plasma twice a week to help pay off my student loans because my bills are all becoming so expensive. It's becoming hard to afford life alone, and I am so afraid I will never make my way. The last WAGE\$ check I received allowed me to start my savings account, which has remained an amazing place since then. I can only imagine how grateful parents who work in this field would be to receive funds like this. We work incredibly hard for our money; this field is not easy, and being compensated for all our hard work makes us feel appreciated.

The early years are critical to a child's development, and this program is a way to help retain qualified staff. Wouldn't you want qualified individuals taking care of your child? This is a field you should want to be in and have a passion for. Sadly, this is not always the case because those who are qualified go elsewhere where they can make a better living for their families. The economy has been incredibly scary these past several years, and it's only worsening. Early education centers are losing qualified staff left and right because of the pay scale in these places. It's so hard to find staff for the building, so the teachers in these facilities are

overworked and underpaid. We hardly hear thank you, and nobody thinks of us as educators, so that can't be further from the truth. The children in my classroom learn so much daily, and keep in mind, I work with the youngest age group. These children are learning sign language, social and emotional skills, and developing their large and fine motor functions, and our teachers are contributing to so much of this development. The future of this world is in these centers, and they have the power to make a difference; this is why you need qualified and decent individuals in these places to help make that difference.

Remember that these kids are spending about forty hours a week with us. These children deserve qualified teachers; keeping this program going is one way to entice them to stay in the field. Please consider funding this program for the foreseeable future; it has made a difference for me and many others. Thank you for your consideration.
