Re: Testimony in FAVOR of House Bill: H 5526: RELATING TO HUMAN SERVICES-THUNDERMIST FAMILY MEDICINE RESIDENCY PROGRAM

Dear Chairperson Abney and Members of the House Finance Committee:

As co-chairs of the Care Transformation Collaborative of Rhode Island's (CTC-RI) Primary Care Workforce Taskforce, we write in strong support of the Thundermist Family Medicine Residency Program and the need for critical investment in primary care health center teaching residencies.

CTC-RI's mission is to strengthen and transform primary care to achieve better health outcomes, better patient experiences, and lower costs for Rhode Islanders. A cornerstone of this mission is ensuring a well-trained, sustainable primary care workforce. Teaching Health Centers—like the one being developed at Thundermist—directly advance this goal by training future physicians in high-quality, team-based, community settings.

Rhode Island faces a serious and growing shortage of primary care providers. By 2030, the state could face a shortfall of 200–300 clinicians, jeopardizing access to timely, preventive, and comprehensive care—especially for our most vulnerable populations. Expanding family medicine residency capacity is one of the most effective strategies to address this challenge.

The benefits of Teaching Health Centers go beyond workforce development. These programs create immediate access to care—residents begin seeing patients on day one—and drive local economic impact through job creation, community partnerships, and talent retention. Data show that when physicians train in Rhode Island, they are much more likely to stay and practice here. The Thundermist Family Medicine Residency, backed by federal funding and national accreditation, is ready to begin training the next generation of primary care physicians—Rhode Islanders serving Rhode Islanders.
