BY Potter, Boylan, Tanzi, Batista, Donovan, Caldwell, Cruz, Fogarty, McGaw, Ajello **ENTITLED,** AN ACT RELATING TO CRIMINAL OFFENSES -- WEAPONS (Prohibits the operation of an outdoor gun range within one mile or closer of any kindergarten through grade twelve (K-12) schools.) {LC3798/1}

This bill has been introduced each year, and to say it is absurd, is an understatement. Many private and POLICE ranges in this state were in existence long before schools were built nearby. Most activities taking place on these ranges, occur on weekends. I attended Cranston West before there was a Western Hills school with Cranston West being in close proximity to the CPD shooting ranges. We heard the police practice at the range, and it was NEVER an issue.

If having a school near a range was so dangerous or threatening to children, then why have so many cities and towns built schools within close proximity to shooting ranges?
