**BY** Potter, Boylan, Tanzi, Batista, Donovan, Caldwell, Cruz, Fogarty, McGaw, Ajello **ENTITLED,** AN ACT RELATING TO CRIMINAL OFFENSES -- WEAPONS (Prohibits the operation of an outdoor gun range within one mile or closer of any kindergarten through grade twelve (K-12) schools.) {LC3798/1} This bill has been introduced each year, and to say it is absurd, is an understatement.
