Bruen decision: The 6-3 ruling, written by Justice Clarence Thomas, is the court's first significant decision on gun rights in over a decade. In a far-reaching ruling, the court made clear that the Second Amendment's guarantee of the right "to keep and bear arms" protects a broad right to carry a handgun outside the home for self-defense.

Going forward, Thomas explained, courts should uphold gun restrictions only if there is a tradition of such regulation in U.S. history.

What part of shall not be infringed don't we understand? Stop thumbing your nose at SCOTUS! **Please oppose House Bill H7217.**
