To all RI House and Senate members

I am a 52 year old lifelong RI resident as is my entire family. I am a husband and father and have spent my entire working career researching

and making medications to help ensure patients receive the critical care they need and yet here I am once again regretfully forced to take time away from my family to pen this letter to you, the representatives of the people of the State of RI.

I am writing in strong objection to the persistent attempts at these unconstitutional gun control measures being debated in both the House and Senate, specifically HB7217, HB7268, HB7269, HB7373, HB7829, SB2202, SB2218, SB2219, SB2653, SB2734. I object to any politicians telling me what I do or do not need, what I can and how often I can purchase a firearm, that I need to take a test and then continue to retest to exercise a right, or how to store what I own in my home. As a law abiding citizen, all of this is my business, not yours.
