RE: In support of H5300 - An Act Relating to Criminal Offenses - Threats and Extortion

Dear Chair Craven,

I write this letter in support of House Bill 5300, legislation that will amend the *Threats to Public Officials* statute to include election officials and poll workers. This will ensure that election officials and poll workers, who carry out the essential functions and duties of our democracy, are protected against threats, intimidation, and harassment.

As Secretary of State, one of my top priorities has been to increase platforms for civic engagement, specifically working with youth across the state, informing them of the electoral process and how they can get involved – volunteering or working as a poll worker is certainly one of the many avenues to do so. We should guarantee to all those who help in the administration of our elections that they are protected from the consequences of misinformation which has led to senseless acts of violence.

For decades, public officials and public servants have been protected by law from threats, intimidation, and harassment. However, election officials and poll workers have not been included, and unfortunately, since 2020, they have been subjected to harassment and threats all over the country. For instance, election officials in Washington and Oregon have received letters containing fentanyl – a drug found to be deadly. During the 2024 election cycle, in an attempt to intimidate election officials, several states received packages containing white powder, including the Rhode Island Board of Elections. Additionally, there was an attempted swatting at my home in the days before the election – although I am protected by the existing statute, Board of Elections staff, local canvassing authorities, and poll workers are not.

Since 2020, nineteen states have enacted laws specifically seeking protections for election officials and poll workers. It is evident that this legislation is critical across the country, and we should address the issue in our state to reassure our election officials and poll workers that they will, at a minimum, be protected from violence and harassment.

Therefore, I urge this committee to support House Bill 5300, as it is imperative that we protect the people who are on the frontlines administering our elections – ensuring our democracy is kept alive so that all eligible Rhode Islanders can cast their vote and have confidence in the way we run our elections.
