Dear Representative Craven and House Judiciary Committee Members,

I am writing about the H-5436 Assault Weapons Ban proposed legislation. I am against passage of this bill.

I have been a responsible gun owner for over 40 years. I am a certified safety firearms instructor, and as such, I have taken numerous safety and gun handling courses. I have taught others, including my wife and nieces, how to safely handle and store guns.

H-5436 is a misdirected law that is also unconstitutional. This proposed legislation will ban a wide group of firearms owned by law-abiding citizens and overnight effectively make us felons. It does nothing to address crime on our streets or gang members using guns - that is the real problem that needs to be looked at, **not** punishing law-abiding citizens.
