My name is David Nunes, I am 60 years old, a disaffiliated registered voter and I am a lifelong resident of Rhode Island. I strongly oppose the upcoming gun control legislation. Recently, the Lt. Gov. stated that she wants to eliminate all guns in Rhode Island. I am new to the 2A community. My family never owned guns. My father and uncles served during the Korean era. My siblings and I never served in the military.

I've been married to the same wonderful woman since 1991. A few years ago there was chatter about defunding the police. She expressed concern on how to protect ourselves if the police are so defunded that they won't be responding for a significant amount of time. We proceeded to get training from an instructor at Mid-State in Coventry. We purchased our first pistol. The rest is history. ## I SUPPORT:

- SB 142 -Constitutional carry for all residents over the age of 21
- SB 65 -Adds on appeal process for those who have been denied a carry permit
- SB 146 Allows for out of state concealed carry permits to be valid in Rhode Island
- SB 144 Permits possession or use of device that muffles sound on any firearm longer than 17"
- SB 150 Would re-legalize silencers in the state of Rhode Island. "Not" a suppressor freedom bill residents would still need to comply with all current federal law.

## I OPPOSE:

- HB 5069 Limits acceptable reasons for a person to request/apply for a concealed carry license.
- HB 5130 Would require "all crime guns" to be submitted to the ATF for testing and tracing.
- SB 59 Would require all "crime guns" to be submitted to the ATF for testing and tracing.
- HB 5443 Allows individuals to voluntarily add themselves to a watchlist that would restrict their right to purchase or possess a firearm.
- HB 5436 An "assault weapons" ban to prohibit the future possession, purchase, sale, control, and manufacture of commonly owned firearms. As a reminder from our previous alert., Governor McKee's FY 2025 budget proposal that was submitted to the General Assembly ALSO included a so-called "assault weapons" ban.
