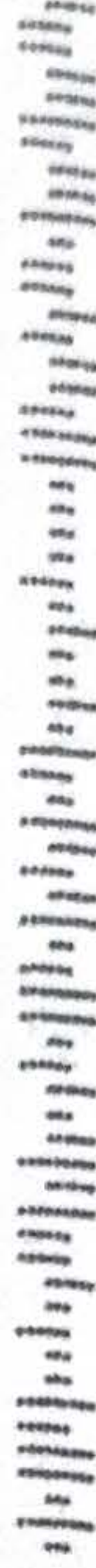

I KNOW I was a boy, NOW.

I was pretending to be a man completely unaware of the very real consequences.

What hurt me the most, was the discovery upon introspection that my consequences are burdened by my family.

My children deserve a father, My mother deserves her son, I may not deserve my chance RIGHT NOW but I will continue grow and demonstrate why I should earn my second chance.

I appreciate y'all time and representation of those disenfranchised effortlessly cast aside as though rehabilitation is a myth.

I am grateful and humbled by the mere idea, the thought of being able to earn a second chance. I came to prison a ranked gang member with the justification that I was a product of my environment.

I am now a righteous man with the supreme understanding, we all have choices, we Always had a choice and I chose wrong. As the boy grew to manhood I've since placed childish thing aside and focused on education as this is the only way to combat the ignorance that has brain washed so many men in my family and tricked them out of their freedom.

Thank y'all again, even for the consideration as it proves society is changing it's perception.

Change is attainable with dedication and education. Until then take care & thank you.
