Hi Steve, It's been a long time since P1-MAX and Marietta's Art classes, Glad you been out still helping; Hi Mario, I Recently watched you leave And hope you've got a training Dog or your own travel companion.

Hi Kyle, Glad you & Steve & Mario Are involved where it's needed.

As for why it's important to me for the phone calls to be free, the E-mails And Video Visits, 1) Basically because of the expense to our family's & friends who pay for us, And also for those of us who have lost most or all of our Family & supporters (Video Visits for us who have kids & Grandkids ^{out of} state.)

After Almost 30 yrs and paying for my own calls w/ inmate pay, the system's phone hanging up on us / muting calls to interrupt the time and help from those we call, Securus And GTL's Histories of abusing And price gouging (when paid) Paying to us were not equally distributed, during the last phone change and law suit. Also the D.O.C was given money's under the Covid Relief and Cares Act Settlements to give us Free calls And tablets, charging a \$13 to \$16 dollar Subscription fee each month and the Wi-fi - not working much of the month. We first Paid for MP3 players and \$5 a song when the rest of the world paid 99¢ or Nothing to download a song. The mp3 sold to us for over \$60 And the rest

of The world, paid \$15 to \$29 for the MP3. The (MP3) Keefe Commissary's Warrantee and Subscription Contract gave us the capability to Buy 4000 Songs. Then they shut off that Feature on our Kiarscs. Thying to force everyone to By the Tablets, and to send the MP3 out or throw it away. Since Then they gave out Tablets, And Now they Give the tablet w/o A charger and Headphones or Ear Budz - And if we do transfer the music on our MP3's to the Doc owned Tablets - When we give their tablets back - the \$ we spent on the MP3 And Songs Are Gone.

Me, I've Chosen to Keep my MP3, But Since coming to medium, they took our Radios And Batteries And or Faced us to send them out w/ A visitor or throw them away. Claiming inmates use Batteries to light Drugs (K2) Punishing everyone For the wrongdoings of A Few. They Also dont let our mail in / they Photo copy it, No Colored Envelopes is their latest Rule, Sending our mail Back After our Family's pay for the Greeting cards to send us, claiming that K2 or whatever is coming in the mail. No Regular mail, And the CRAP is still here - well, we can Guess how its in here - The Doc Doesnt want to stop it because they wouldnt have the discipline, to cry SAFETY & Security issue

The Doc modifies our Recs And locks us
Down so much - When we use the phone to
complain to Family Friends or Legal Helpers,
They shut the phones off w/o warning; And
IF we had the Free phones on the Regular
phones or our Tablets The Doc would still
monitor them for content - The EMAILS
on the Coors Link Tablets Take 4 Hours
or more to Go in And or out.

I've Got (1) Foot out the Door And I'm
at the end of A 30 yrs term And A 2/2yr
consecutive, And wish to continue bringing
Awareness to what has been, And not been.
Everything Here Amounts to No Accountability
For things they should do And Dont And no
Accountability for things they DO And Should not
do - Some things have changed (A little) like the Discipline,
But they Always Find A way to [lead the problems up]
And create them so they can go to the Public and
Say its worse. This letter could be longer, And
I intended it to Be (1) page. I Hope it helps
And Hope you will contact me to Also help from
the outside world - As my Time is About to be in
A much changed world within 18-20 months (Tomorrow in
6 yrs old w/B Still Beating 20 yr old SAT Handball!)
