

LOST MANY FAMILY MEMBERS TO PASSING AWAY.
I HAVE SEEN THE EFFECTS THAT MY DRUG ABUSE
HAS HAD ON ALL THOSE THAT WERE IN MY LIFE.

Now that I am drug free, I see ALL the pain that I caused others. My family and I are closer now and I pray that I will have the chance to be with them again.

I am currently enrolled in the garden program as well as some bible study courses and I attend Christian services weekly.

I think that this Second Look Act will benefit a lot of people in a positive way. There are so many of us whom have changed our lives for the better.
