Sadly, although national in scope, these issues are not unfamiliar in Rhode Island. Indeed, when sentencing Robert C. Devaney, (convicted of sexual offenses with Providence special education students) then Superior Court (now RI Supreme Court) Justice Maureen McKenna Goldberg stated:

"The employment background of this defendant who was shuffled from one school department to another, from one bureaucrat to the next, is a crime in itself." Shweizer, The Dance of the Lemons, Hoover Institution Digest, <https://www.hoover.org/research/dance-lemons>, January 30, 1999.

The devastation such teachers wreck upon students and families in Rhode Island is incalculable.

Action by the legislature is required to put an end to such practices.
