At its meeting held on March 9, 2026 the South Kingstown Town Council considered a request from South Kingstown Town Council Vice President Marran to support House Bill H7224 relating to the statutory small purchase limits applicable to municipal procurement and a request from Representative Teresa Tanzi to support House Bill H8010 authorizing the business located at 349 Main Street, Wakefield, RI to have liquor service within a 200 foot proximity of a church.

We request that you support passage of this legislation in the 2026 session of the General Assembly.

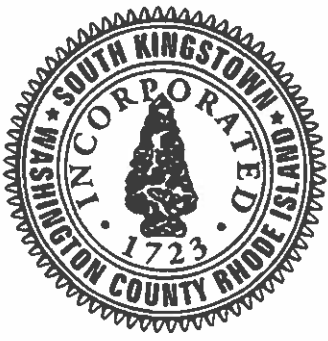


