

## Alliance of Rhode Island Southeast Asians for Education Organizational Testimony in Support of Senate Bill #HB5515

ARISE stands in full support of House Bill 5515, which champions the implementation of same-day voter registration in Rhode Island. Our endorsement of this bill is grounded in the belief that a healthy democracy flourishes when it is inclusive, accessible, and responsive to the needs of all its citizens.

In recent years, we have witnessed a troubling decline in young voter turnout, with the figures plummeting from 59% in 2020 to a mere 22% in 2022. The implementation of same-day voter registration presents a critical opportunity to reverse this downward spiral and reinvigorate the participation of Rhode Island's youth in our electoral process. Empirical evidence has shown that such measures can significantly boost turnout among young voters, potentially increasing participation by 3.1 to 7.3 percent, particularly marked during presidential elections.

This crisis is exacerbated by how antiquated and racially inequitable Rhode Island's voter registration policies are. Rhode Island's existing voter registration deadline stands as the most restrictive in the United States, disenfranchising recently naturalized U.S. citizens and residents who move between cities or towns. Moreover, in 2024, 2,311 Rhode Islanders registered after the arbitrary deadline and were consequently unable to vote in the general election. These figures starkly illustrate the barriers that our current system poses to voter participation, especially impacting Black, Latinx, and other communities of color who are nearly twice as likely to rent and move frequently.

House Bill 5515 seeks to dismantle these barriers by fostering a more equitable voting

landscape and allowing newly naturalized citizens to participate immediately following their naturalization. Furthermore, our state already has the necessary infrastructure to support same-day registration, as demonstrated in 2024 when 9,187 people registered and voted on Election Day for the president and vice president—roles that federal law mandates must allow same-day registration.

Moreover, 61% of Rhode Islanders support same-day registration, signaling a clear mandate from the public for this legislative body to act. It is also worth noting that Rhode Island is an outlier in the New England region, where same-day voter registration is already a reality in four out of six states. The enactment of this bill would harmonize our state with a growing national trend that embraces electoral inclusivity, as 22 states plus the District of Columbia have already adopted same-day registration practices.

The merits of House Bill 5515 extend beyond enhancing voter turnout. It aims to eliminate arbitrary and onerous deadlines, improve the accuracy of voter lists, and alleviate the burden on election administrators by decreasing reliance on provisional ballots. By doing so, we can ensure that every eligible voter has the opportunity to register and cast a ballot that counts on election day.

In conclusion, ARISE urges the General Assembly to affirm Rhode Island's commitment to a vibrant democracy by passing House Bill 5515. Let us align with the values of inclusivity and representation by enabling same-day voter registration. Let us fortify the cornerstone of our democracy by empowering every citizen to participate in the electoral process. For Rhode Island, for democracy, for the future—we stand in solidarity with the passage of House Bill 5515.
