Dear Chair Donovan and members of the Committee:

My name is Tim Paul. I am the father of five, with two having Type 1 Diabetes.

I am writing to you to support House Bill No. 7075 **THE MATTHEW FEDERICO DIABETIC SAFETY ACT**, and House Bill No. 7188 to cap the cost of insulin and glucose monitoring.

I have seen both of my Type 1 Diabetic sons (now adults) struggle with the costs of supplies that are needed to keep them alive. Our family struggled with those costs as all of my children were growing up. I can recall many times when we were struggling to make ends meet because we were charged the full amount for insulin administration supplies, until we could get things settled out with the insurance company.

Additionally, I have witnessed the dangers for both of them not being able to treat their disease appropriately. Glucagon is necessary to prevent death by severe low blood sugar. Again, our family and our sons have experienced times when we only had expired glucagon because we could not renew the glucagon as frequently as needed due the costs. The cap on the cost of insulin and glucose monitoring enables them to stay healthy, keeping them out of the hospital and from incurring alternative sick and urgent healthcare costs associated with keeping them alive.

I ask you to please support both bills, as the legislation will improve the lives of those living with diabetes.
