

RITT - Outside collection services

How much, if any, of Traffic Tribunal receivables have previously been referred to outside collection services?

- In researching a response to this question, the CCU has spoken to representatives of the RITT, the Supreme Court Administrator and the Supreme Court's Assistant Administrator for Finance and Budget.
- The Traffic Tribunal was established in 1999, pursuant to Rhode Island General Laws Chapter 8-8.2.
- The Traffic Tribunal, as currently constituted, has never retained an outside collection agency and the referrals
 recently made to the CCU are the first time the Traffic Tribunal has referred its debts to an outside entity for
 collection.
- The Administrative Adjudicative Court was extinguished in 1999.
- The Supreme Court's Assistant Administrator for Finance and Budget recalls that that the Administrative
 Adjudicative Court retained an outside collection agency many years ago, but there is no documentation that can
 be found concerning any interactions between the Administrative Adjudicative Court and that collection agency.



- 398,952 people are not scheduled for renewal prior to May 2023.
- $\bullet \quad$ Anticipated 55% of those will come in to get a Real ID prior to renewal .
- 50,400 update/duplicate Real ID transactions have been completed resulting in increased revenue.
- 7 months remain until the Real ID deadline of May 3, 2023.
- 39% of current credential holders are Real ID compliant.
