#### **Historical Context**

Rhode Island Vision Education and Services Program (RIVESP) was created by legislation in 2006, and provides:

- vision assessment, direct instruction and consultation with classroom teachers and families
- includes vision instruction/support as well as orientation and mobility services
  - Certified Teachers of the Visually Impaired (TVIs)
  - Orientation and Mobility Specialist (O&M)



### Supporting Statewide System

- Since inception, RIVESP has been financially supported in part through a contract with RIDE utilizing
  - State General Revenue
  - Fee-For-Service from Local Education Agencies (LEAs)
- In addition, IDEA Part B State Discretionary Funds
  - Typically used for statewide capacity building; RIDE as the state agency chose to use it specifically for this purpose
  - This is **the only program** for direct services to children that RIDE subsidizes, since 2006
- The five-year Sherlock Center contract was scheduled to end in 2020
  - Due to the significant concern for consistency of services for the students, and the financial concerns raised by the program, RIDE:
    - extended contract under state procurement rules to 2021, and
    - voluntarily increased IDEA Funding by 5%
    - Current funding level from RIDE \$684,600 (<u>all</u> IDEA Part B funds) <u>all</u> allocated to the Sherlock Center




### 2020-2025 RIVESP Agreement

- New expectations
  - Educator evaluation
  - Data reporting
- Term of agreement is for five years
- IDEA Part B was committed for the term of the agreement

#### Program Review in 2019-2020

- With the Sherlock Center's new leadership and in anticipation of a new contract, RIDE engaged in a program review in November of 2019
  - The general findings were:
    - Since 2015, district participation in the Sherlock Center's program declined
      - Some LEAs hired their own vision teachers
      - Some LEAs were using a different vendor
      - Program costs continued to increase
        - Staffing levels, operating costs, and contractual obligations



## Medicaid Eligibility in 2020

- In an effort to find other ways to maintain services for the students, provide revenue for the Sherlock Center and the non-participating LEAs, RIDE worked with the EOHHS to add allowable reimbursement (codes) for vision services as Medicaid reimbursable services
  - Allows LEAs to seek Medicaid reimbursement for eligible students
  - Intended to reduce the fiscal burden on LEAs
  - Bolster the funding for the Sherlock Center
- This was implemented with LEAs in November 2020
