History

- 2008 Assembly consolidated public safety agencies into single department
 - To achieve efficiencies in training & facilities
 - Superintendent of State Police also serves as director of Department
- 2011 Assembly included Sheriffs
- 2018 Assembly moved Fire Marshal into the Department of Business Regulation



Staffing – FY 2024 New Positions

- 2023 Assembly included 2.0 new positions for FY 2024 within current staffing authorization
 - Division of State Police
 - 1.0 Fleet Operations Civilian
 - 1.0 Digital Forensic Analyst
 - Both positions are currently filled

Records Management System


- 2021 Assembly empowered DPS to implement a statewide records management system
 - Law enforcement agencies will be able to utilize the system for a fee
 - Deposited into a restricted receipt account
- Governor recommends \$2.8 million primarily from E-911 receipts for implementation
 - Phase I projected to cost \$3.0 million in FY 2025
 - DPS in discussions for alternative funding
- Governor also includes \$0.2 million from general revenues for project manager
 - Within current staffing authorization

Statewide Body-worn Camera Program

- \$13.5 million from general revenues in FY 2024 enacted budget
 - Body cameras for State Police & municipalities
 - Governor recommends \$14.0 million for FY 2024
 - Includes \$0.5 million reappropriated from FY 2023
 - \$1.3 million spent so far during FY 2024
 - Unexpended funds would be reappropriated to FY 2025

Central Management

- Manages budgeting, planning, and purchasing functions
- Administers federal grant programs
 - Public Safety Grants Administration Office
- 14.0 positions recommended
 - 0.4 more than enacted
 - Funded at current service level

Support for Survivors of Domestic Violence

- Governor recommends \$10.5 million from ARPA funds for awards to nonprofits for domestic violence and assault victims
 - Revised budget includes entire authorization
 - No funds were spent in FY 2023
 - Unused funds from FY 2024 will be reappropriated to FY 2025.
 - Awards prioritize housing assistance, job training, relocation aid, clinical & mental health service
 - Spent \$14,725 through end of February



 - \$83.3 million for 328.0 positions
 - \$75.9 million from general revenues
 - \$0.5 million less than enacted
 - \$0.3 million less than requested
 - Reflects turnover savings, increase in overtime, and current service adjustments
 - Request not funded
 - Trainee Troopers 5.0 FTE
 - GBA #4 repurposes \$1.2 million from additional turnover savings for Training Academy

- State Police Training Academy
 - DPS requested \$1.4 million for a FY 2025 class
 - Classes typically occur every two years
 - Governor did not recommend the funding
 - FY 2024 Training Academy
 - Projected to have 40 candidates
 - Only 29 trainees as of early March
 - GBA #4 repurposes \$1.2 million from additional turnover savings for a FY 2025 class

- Vehicle Cameras
 - Governor recommends \$2.1 million from general revenues for all patrol vehicles
 - Five-year contract includes service agreement
 - Vehicle camera systems used in tandem with bodyworn camera systems
 - Complete documentation of police interaction with public

- Public Safety Communications Services
 - 24-hour statewide emergency communication services
 - Routes emergency calls to first responders
 - Public outreach programs
 - Encourages families to teach children about 9-1-1
- 2019 Assembly created new restricted receipt account exclusive for E-911
 - Funded by surcharges on wired, wireless, & prepaid phones
 - \$0.50 per wired and \$0.75 per wireless line

- Staffing Emergency Medical Dispatch
 - 2021 Assembly mandated implementation of emergency medical dispatch system
 - 2022 Assembly provided 6.0 new positions for proper staffing during implementation
 - System went live on July 26, 2022
 - Staffing plan implemented to ensure proper staffing
 - Overtime used to supplement when necessary
 - Increase in calls compliant with standard set by International Academies of Emergency Dispatch

- Salaries and Benefits
 - \$6.3 million for 56.0 positions
 - \$0.4 million less than enacted
 - \$0.1 million more than requested
 - Reflects turnover savings and current service adjustments
 - Assumes average of 51.0 positions filled
 - March 23 pay period 10.6 vacancies

- Technology, Upgrades, and Maintenance
 - \$1.9 million for FY 2025
 - \$0.3 million less than enacted
 - Completed Indigital's Next-Gen i3 optical fiber network upgrades
 - Includes \$0.3 million for video wall at the public safety answering point
 - Will replace outdated laser projectors

- Provide judicial security
 - Courtroom, courthouse cellblocks, and judges
- Transport prisoners
- Extradite wanted persons
- Execute writs of process

- Sheriff Work Week 40 Hours
 - 2022 Assembly provided \$0.1 million for 12 sheriffs to transition to 37.5-hour work week
 - Department used turnover savings to transition all sheriffs
 - Requested \$0.3 million in FY 2024 and FY 2025 to transition all sheriffs to 40-hour work week
 - 37.5 hour 45 sheriffs
 - Governor did not recommend funding
 - Also requested in FY 2023 and FY 2024

- Salaries and Benefits
 - \$21.7 million for FY 2025 for 180.0 FTE
 - \$0.1 million more than enacted
 - Current service adjustments
- Motor Vehicles
 - \$0.6 million for FY 2024
 - Purchase 7 vehicles
 - \$0.3 million annually for fleet maintenance, gas, insurance

Capitol Police

- Perform public safety functions for 16 state buildings & courthouses
 - Funded from general revenues and internal service funds (ISF) billed to other state agencies

 - Includes \$0.3 million for FY 2029

- New Southern Barracks
 - Approved plan \$30.5 million from RICAP
 - Construction of modern barracks for State Police
 - Governor recommends \$7.8 million more
 - Excludes some elements from approved plan to lower costs
 - DPS received initial cost estimate of \$49.0 million
 - Extends the project's completion to FY 2026
 - GBA #6 increases total cost to \$41.3 million
 - Shifts \$1.0 million from FY 2024 to FY 2025
 - Adds \$3.1 million to FY 2026
