Amendments to FY 2024 Appropriations Act (23-H-5200)

The Governor requests an amendment be made to the FY 2024 Appropriations Act. This amendment includes new language in Article 1 by creating a new Section 21 which would exempt the DCYF girls' facility project from municipal zoning or local comprehensive plan requirements. The amendment also includes changes to the appropriation amounts in Article 1, Relating to Making Appropriations in Support of FY 2024 of \$250,000 in Rhode Island Capital Plan Funds (RICAP) for land use planning for state-owned property in the Town of Exeter.

ARTICLE 1, RELATING TO MAKING APPROPRIATIONS IN SUPPORT OF FY 2024 SECTION 1, APPROPRIATIONS IN SUPPORT OF FY 2024

Department of Administration

Increase Other Funds – Rhode Island Capital Plan Funds for the Statewide Facility Master Plan, Page 4, Line 30 by \$250,000 from \$2,200,000 to \$2,450,000. This amendment increases funding for land use planning for state-owned property in the Town of Exeter (24-DOA1).

NEW SECTION 21, APPROPRIATIONS IN SUPPORT OF 2024

Page 50, Insert New Section 21 after Line 29 and insert the following. "With respect to the project and the funds allocated to the DCYF – Residential Treatment Facility, the provisions of Chapter 45-22 and Chapter 45-24 of the General Laws shall not apply."

Page 50, On Line 30, strike 21 and replace with 22.
