### **Target Issues**

Commission provided with General Revenue target of \$1,308,736

- Constrained Request \$50,663 less than target
  - Creation of restricted receipt account for Eisenhower House rental fees
  - Shift related expenses from general revenues to restricted receipts
- Governor's recommendation \$23,744 more than target

## FY 2014 Governor's Recommendation

#### Changes to Enacted Budget:

- Includes Department of Transportation funds for personnel for both FY 2013 and FY 2014
- Increases Rhode Island Capital Plan funds for Eisenhower House Asset Protection
- Overall decrease of federal funds, reflecting expiration of Preserve America grant program

### Personnel

#### FY 2013 Revised

- Total of \$1,627,312 from all funds
  - \$28,011 less than enacted
- Savings from:
  - 2.0 positions vacant for half of the fiscal year
- Includes \$41,264 from Department of Transportation gas tax funds

### Personnel

#### FY 2014

- Total of \$1,752,731 from all funds
  - \$97,408 more than enacted
  - Funds authorized 16.6 full-time positions
- Consistent with staff salary and benefit selections
- Includes \$84,020 from Department of Transportation gas tax funds

## **Community Service Grants**

- Provides 8 Community Service Grants to veterans' and local preservation organizations
  - \$111,301 total from general revenues
- No change to FY 2013 budget as enacted

## Eisenhower House – Asset Protection

- Transferred from the Navy to the state in 1964
- Per the transfer agreement, the state has affirmative obligation to maintain the property
- Rhode Island Capital Plan funds used for asset protection since FY 2012
  - Repairs previously funded from general revenues

## Eisenhower House – Asset Protection

- Larger scope of construction and repair work needed to rehabilitate property than previously anticipated
- Governor's Recommendations
  - FY 2013 revised: \$175,000 from RICAP funds
  - FY 2014: \$1,000,000 from RICAP funds

### Heritage Harbor Museum

- Planned as state's first statewide history museum and Smithsonian Institution affiliate
  - Located at South Street Power Plant
- In 2002 bond referendum, voters authorized
  \$5.0 million for the museum
- \$3.8 million issued, \$1.1 million expended
  - \$0.3 million annual debt service

### Heritage Harbor Museum

- \$1.2 million unissued
  - Extended by 2009 and 2011 Assemblies
  - Expires June 30, 2014
- Governor recommends for FY 2018:
  - \$2.7 million remaining of issued
  - Issue of unissued \$1.2 million
- Construction ceased in March 2009
  - Project now effectively defunct
