 - Serve as the liaison to the state's arts community
- Mission
 - Serve as a catalyst for advancement, appreciation and promotion of excellence in the arts
 - Encouraging leadership, participation, and education in the arts for all Rhode Islanders

 Envision a Rhode Island where all people have an opportunity to participate in the arts, where the arts contribute to the social, economic and educational well-being of our state, and where the arts are valued by all Rhode Islanders as an integral part of life

Target Issues

- Budget Office provided a general revenue target of \$1.8 million
 - Current service adjustments of \$7,220
 - 8.0% reduction of \$0.1 million
- Council's constrained request met the target
 - Proposed reduction in discretionary grants
- Governor recommends \$0.1 million more than target

Statewide Savings

- Assessment to salaries that funds workers' comp., unemployment & unused leave
 - Lowered from enacted based on experience
 - Savings of \$1.2 million in FY 2017
 - Savings of \$1.5 million in FY 2018
- Medical benefit cost growth
 - Lower than initial estimates
 - Savings of \$2.6 million in FY 2018
- Total impact to Council
 - \$1,111 in FY 2017; \$2,459 in FY 2018

Personnel

- Governor recommends 8.6 full-time positions for FY 2018
- \$0.9 million from all funds for FY 2018
 - \$0.7 million from general revenues
 - \$5,256 less than enacted
 - \$0.2 million from federal funds
 - \$3,685 more than enacted

RI Film & Television Office

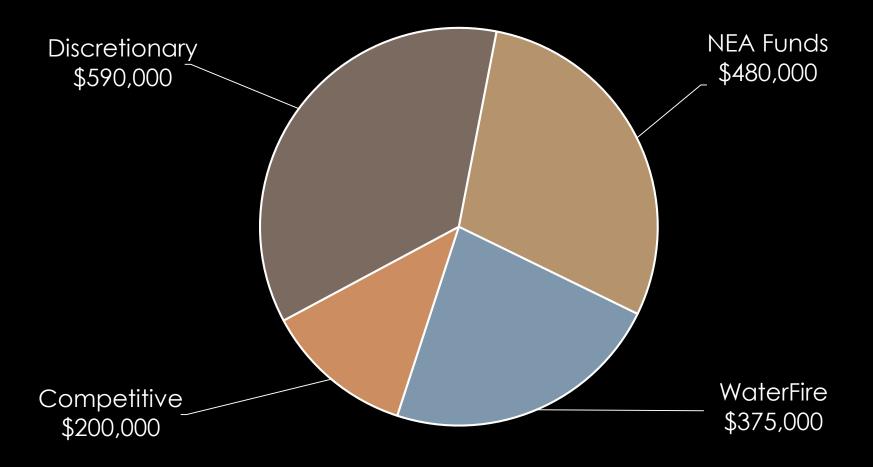
- Responsible for promotion and encouragement of film and television productions within state
- Responsible for the review of applications for Motion Picture and Theatrical Production tax credits
 - Annual cap of \$15.0 million
 - Program sunsets on July 1, 2021

Grants

- For artists & organizations throughout RI
- \$1.7 million for FY 2017
- \$1.6 million for FY 2018
 - General Revenue
 - Discretionary
 - Competitive
 - WaterFire Providence
 - Identified in Article 1
 - Federal National Endowment for the Arts

Percent for Arts

- As of January 1, 1988, all state buildings or facilities constructed, remodeled, or renovated shall include works of art for public display
 - At least 1.0% of the total cost of project
- Governor recommends \$1.0 million for FY 2017 and \$0.3 million for FY 2018
 - Reflects updated FY 2017 project costs and anticipated completion dates

Creative and Cultural Economy Bond Funds

- Total of \$35.0 million from new G.O.
 bonds
 - Approved by voters in November 2014
- Council: \$30.0 million
 - Renovations to nonprofit theaters and performance spaces
- Historical Preservation and Heritage Commission: \$5.0 million
 - Historic sites and nonprofits
