ARTICLE 1, RELATING TO MAKING APPROPRIATIONS IN SUPPORT OF FY 2016

SECTION 1, APPROPRIATIONS IN SUPPORT OF FY 2016

Department of Administration

Increase General Revenue Funds, Page 7, Line 8 by \$100,000, from \$25,225,000 to \$25,325,000 Personnel and Operational Savings. This restores savings associated with Article 27 – Relating to Legal Notices, which was requested to be withdrawn on March 25, 2015.

Executive Office of Health and Human Services

Decrease General Revenue Funds, Page 15, Line 13 by \$1,973,138 from \$1,973,138 to \$0. This decrease reflects withdrawal of the proposal to establish a Division of Advocacy and restoration of funds to the individual advocacy agencies. This change coincides with the requested withdrawal of Article 18.

Decrease Federal Funds, Page 15, Line 14 by \$53,125 from \$53,125 to \$0. This decrease reflects withdrawal of the proposal to establish a Division of Advocacy and restoration of funds to the individual advocacy agencies. This change coincides with the requested withdrawal of Article 18.

Decrease Restricted Receipt Funds, Page 15, Line 15 by \$117,343 from \$117,343 to \$0. This decrease reflects withdrawal of the proposal to establish a Division of Advocacy and restoration of funds to the individual advocacy agencies. This change coincides with the requested withdrawal of Article 18.

Department of Health

<u>Decrease State Loan Repayment Match – Restricted Receipts, Page 17, Line 6 by \$50,000 from \$24,520,035 to \$24,470,035.</u> This decrease reflects an updated availability of funds to support the Loan Repayment Program. An estimated \$125,000 will be available to support this program in FY 2016.

Governor's Commission on Disabilities

Increase General Revenue Funds, Page 20, After Line 15, by \$383,056 from \$0 to \$383,056. This increase reflects restoration of financing to the Governor's Commission on Disabilities from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Increase Federal Funds, Insert After Previous Addition, by \$35,459 from \$0 to \$35,459. This increase reflects restoration of financing to the Governor's Commission on Disabilities from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Increase Restricted Receipts, Insert After Previous Addition, by \$10,009 from \$0 to \$10,009. This increase reflects restoration of financing to the Governor's

Commission on Disabilities from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Commission on the Deaf and Hard of Hearing

Increase General Revenues, Insert After Previous Addition, by \$411,883 from \$0 to \$411,883. This increase reflects restoration of financing to the Commission on the Deaf and Hard of Hearing from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Increase Restricted Receipt Funds, Insert After Previous Addition, by \$80,000 from \$0 to \$80,000. This increase reflects restoration of financing to the Commission on the Deaf and Hard of Hearing from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Office of the Child Advocate

Increase General Revenues, Insert After Previous Addition, by \$672,273 from \$0 to \$672,273. This increase reflects restoration of financing to the Office of the Child Advocate from the proposed Division of Advocacy. This change coincides with the elimination of Article 18.

Increase Federal Funds, Insert After Previous Addition, by \$45,000 from \$0 to \$45,000. This increase reflects restoration of financing to the Office of the Child Advocate from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Office of the Mental Health Advocate

Increase General Revenues, Insert After Previous Addition, by \$560,304 from \$0 to \$560,304. This increase reflects restoration of financing to the Office of the Mental Health Advocate from the proposed Division of Advocacy. This change coincides with the requested withdrawal of Article 18.

Department of Elementary and Secondary Education

Increase Administration of the Comprehensive Education Strategy – Federal Funds, Page 20, line 20 by \$144,000 from \$193,991,061 to \$194,135,061. This increase reflects second year financing of a new grant titled 'Jobs-Driven NEG Funds, which the Department will use to offer adult education classes to the dislocated workers, particularly, the state's veteran population. The Department will work with local and regional partnerships to expand the population served by this grant.

Increase Administration of the Comprehensive Education Strategy – Federal Funds Stimulus, Page 20, line 21 by \$1,000,000 from \$5,990,558 to \$6,990,558. This increase reflects the full award amount of a new Race to the Top Pre-School Development Grant that the Department was notified of in January, 2015. The grant, expected to be fully utilized in FY 2016, will be used to increase enrollment of four-year-olds in pre-k programs, in high need communities around the state.

RI Historical Preservation and Heritage Commission

Increase Federal Funds, Page 25, line 30 by \$20,500, from \$2,054,893 to \$2,075,393. This increase reflects the second year of expenditure of a new grant awarded to the RI Historical Preservation and Heritage Commission. The grant is from the National Park Service – Department of the Interior and will be used to increase the number of listings in the National Register of Historic Places associated with under-represented communities. The total grant is \$25,000, with \$4,500 recommended to be expended in FY 2015.

Judiciary

Increase Federal Funds in the District Court, Page 28, line 31 by \$213,416, from \$30,000 to \$243,416. This increase reflects the second year of a new Veterans Grant which will be used by the Judiciary to expand outreach to an estimated 250 additional veterans as part of its Veteran's Court activities. The new financing will be focused on a jail diversion program and substance abuse issues of veterans appearing before the court.

SECTION 10, FY 2016 FTE POSITION AUTHORIZATION

Decrease FTE Position Authorization, Page 36, Line 24 from 202.0 to 185.0: This decrease removes the authorization for 17.0 FTE positions transferred from the Governor's Commission on Disabilities, the Commission on the Deaf and Hard of Hearing, the Office of the Child Advocate, and the Office of the Mental Health Advocate to the Executive Office of Health and Human Services. The Governor recommends an FTE position authorization of 185.0 for the Executive Office of Health and Human Services.

<u>Increase FTE Position Authorization, Insert Page 36, After Line 28:</u> Add an FTE authorization of 4.0 FTE positions to the Governor's Commission on Disabilities. This amendment restores FTE positions to the Commission since the Governor has requested to withdraw Article 18.

<u>Increase FTE Position Authorization, Insert After Previous Item:</u> Add an FTE authorization of 3.0 FTE positions to the Commission on the Deaf and Hard of Hearing. This amendment restores FTE positions to the Commission since the Governor has requested to withdraw Article 18.

Increase FTE Position Authorization, Insert After Previous Item: Add an FTE authorization of 6.0 FTE positions to the Office of the Child Advocate. This amendment restores FTE positions to the Office since the Governor has requested to withdraw Article 18.

<u>Increase FTE Position Authorization, Insert After Previous Item:</u> Add an FTE authorization of 4.0 FTE positions to the Office of the Mental Health Advocate. This amendment restores 4.0 FTE positions to the Office since the Governor has

requested to withdraw Article 18. It is noted that the Governor continues to request an increase of 0.3 FTE positions from the FY 2015 enacted authorization of 3.7 FTE positions for the Office.

ARTICLE 10, RELATING TO MAKING REVISED APPROPRIATIONS IN SUPPORT OF FY 2015

SECTION 1, REVISED APPROPRIATIONS IN SUPPORT OF FY 2015

Department of Health

Increase CNOM Medicaid Womens Cancer Screening – Federal Funds, page 138, Line 12 by \$21,908 from \$43,454,988 to \$43,476,896. This increase reflects the addition of federal dollars to fulfill the 1:1 matching requirements of this grant. General revenue financing of an equivalent amount was included in the Governor's budget submission.

<u>Decrease State Loan Repayment Match – Restricted Receipts, Page 138, Line 14 by \$313,750 from \$26,206,939 to \$25,893,189.</u> This decrease reflects an updated availability of funds to support the Loan Repayment Program. An estimated \$125,000 will be available to support this program in FY 2015.

Department of Human Services

Increase Veterans' Affairs – Total, Page 139, Line 13 by \$50,000 from \$29,923,767 to \$29,973,767. The increase reflects an additional \$50,000 from restricted receipts to complete a survey of several acres of land identified for use as burial plots under the Veterans' Cemetery's Master Plan. This additional financing was included in the restricted receipt total on line 12, but inadvertently omitted from the totals for the Division, Department, and the State in Article 10. The Grand Total on Page 140, Line 7 will also be increased by \$50,000 from \$627,883,574 to \$627,933,574 to reflect this update.

Department of Elementary and Secondary Education

Increase Administration of the Comprehensive Education Strategy – Federal Funds, Page 142, line 18 by \$393,994 from \$194,510,540 to \$194,904,534. Of the total amount, \$144,000 reflects first year financing of a new grant titled 'Jobs-Driven NEG Funds, which the Department will use to offer adult education classes to the dislocated workers, particularly, the state's veteran population. The Department will work with local and regional partnerships to expand the population served by this grant. The remaining amount of \$249,994 is for projects in the Longitudinal Data Systems program that are being funded in FY 2015 with federal carry over funds from the previous year.

Increase Administration of the Comprehensive Education Strategy – Federal Funds Stimulus, Page 142, line 19 by \$3,030,163 from \$15,579,652 to \$18,609,815. This amendment is comprised of \$2,000,000 more for the Race to the Top Stimulus
