The amendments include changes to appropriation amounts in Article 1, Relating to Making Appropriations in Support of FY 2016, and Article 10, Relating to Making Revised Appropriations in Support of FY 2015.

ARTICLE 10, RELATING TO MAKING REVISED APPROPRIATIONS IN SUPPORT OF FY 2015

SECTION 1, REVISED APPROPRIATIONS IN SUPPORT OF FY 2015

Department of Health

<u>Increase CNOM Medicaid Womens Cancer Screening – Federal Funds, page 138, Line 12 by \$21,908 from \$43,454,988 to \$43,476,896.</u> This increase reflects the addition of federal dollars to fulfill the 1:1 matching requirements of this grant. General revenue financing of an equivalent amount was included in the Governor's budget submission.

<u>Decrease State Loan Repayment Match – Restricted Receipts, Page 138, Line 14 by \$313,750 from \$26,206,939 to \$25,893,189.</u> This decrease reflects an updated availability of funds to support the Loan Repayment Program. An estimated \$125,000 will be available to support this program in FY 2015.

Department of Human Services

Increase Veterans' Affairs – Total, Page 139, Line 13 by \$50,000 from \$29,923,767 to \$29,973,767. The increase reflects an additional \$50,000 from restricted receipts to complete a survey of several acres of land identified for use as burial plots under the Veterans' Cemetery's Master Plan. This additional financing was included in the restricted receipt total on line 12, but inadvertently omitted from the totals for the Division, Department, and the State in Article 10. The Grand Total on Page 140, Line 7 will also be increased by \$50,000 from \$627,883,574 to \$627,933,574 to reflect this update.

Department of Elementary and Secondary Education

Increase Administration of the Comprehensive Education Strategy – Federal Funds, Page 142, line 18 by \$393,994 from \$194,510,540 to \$194,904,534. Of the total amount, \$144,000 reflects first year financing of a new grant titled 'Jobs-Driven NEG Funds, which the Department will use to offer adult education classes to the dislocated workers, particularly, the state's veteran population. The Department will work with local and regional partnerships to expand the population served by this grant. The remaining amount of \$249,994 is for projects in the Longitudinal Data Systems program that are being funded in FY 2015 with federal carry over funds from the previous year.

Increase Administration of the Comprehensive Education Strategy – Federal Funds Stimulus, Page 142, line 19 by \$3,030,163 from \$15,579,652 to \$18,609,815. This amendment is comprised of \$2,000,000 more for the Race to the Top Stimulus

grant, from \$7,452,730 to \$9,452,730 to close out this grant, which ends June 30, 2015. The remaining increase of \$1,030,163 is for the Race to the Top Early Learning Challenge Grant, because projects expected to start in FY 2016 are instead expected to start in FY 2015 with carry over federal funds.

Increase Davies Career and Technical School – General Revenue, Page 142, Line 32 by \$16,796 from \$12,223,378 to \$12,240,174. This adjustment restores a statewide adjustment for medical benefit savings, which when combined with other adjustments, resulted in the removal of \$16,796 from general revenues in the Davies School program. Davies is subject to the education formula calculation, and therefore its financing cannot be changed for statewide adjustments, as was inadvertently done in the Governor's original submission.

Historical Preservation and Heritage Commission

Increase Federal Funds, Page 147, Line 30 by \$4,500 from \$2,255,295 to \$2,259,795. This increase reflects the first year of expenditure of a new grant awarded to the RI Historical Preservation and Heritage Commission. The grant is from the National Park Service – Department of the Interior and will be used to increase the number of listings in the National Register of Historic Places associated with under-represented communities. The total grant is \$25,000, with \$20,500 recommended to be expended in FY 2016.

Department of Attorney General

Increase Federal Funds in the Criminal Program, Page 148, Line 7 by \$27,732 from \$2,679,629 to \$2,707,361. This increase reflects greater availability of federal funds from the Victims of Crime federal grant. This grant funds approximately 50 percent of 1.0 FTE position.

Judiciary

Increase Federal Funds in the District Court, Page 150, line 29 by \$218,803, from \$30,000 to \$248,803. This increase reflects the first year of a new Veterans Grant which will be used by the Judiciary to expand outreach to an estimated 250 additional veterans as part of its Veteran's Court activities. The new financing will be focused on a jail diversion program and substance abuse issues of veterans appearing before the court.

Military Staff

Increase Restricted Receipts, Page 151, line 8 by \$50,000, from \$388,300 to \$438,300. This increase is for the Google Counter Drug account, currently budgeted at \$88,300 which the department has determined is understated in the current year. The Department uses the financing for counterdrug activity only, including training and equipment purchases as per the US Department of Justice award criteria.
