ARTICLE 1, RELATING TO MAKING REVISED APPROPRIATIONS IN SUPPORT OF FY 2019 SECTION 1, APPROPRIATIONS IN SUPPORT OF FY 2019

**Department of Administration**

Decrease Rhode Island Capital Plan Funds – Zambarano Buildings project, Page 3, Line 31 by \$882,000 from \$2,382,000 to \$1,500,000. This amendment reflects projected expenditures by the Division of Capital Asset Management and Maintenance at the Zambarano facility. Elevator replacement project delays require that the remaining balance be shifted in FY 2020 (19-DOARICAP1).

Decrease Rhode Island Capital Plan Funds – Pastore Utility Upgrade project, Page 4, Line 4 by \$387,000 from \$2,575,000 to \$2,188,000. This amendment requests the reduction of \$387,000 from the Governor's budget request of \$2,575,000 due to lower projected spending (19-DOARICAP2).

Decrease Rhode Island Capital Plan Funds – Replacement of Fuel Tanks project, Page 4, Line 6 by \$251,374 from \$355,610 to \$104,236. This amendment moves the projected surplus from FY 2019 to FY 2020 for projects expected to be completed in FY 2020, including the URI fuel tank replacement project (19-DOARICAP3).

Decrease Rhode Island Capital Plan Funds – Big River Management Area project, Page 4, Line 8 by \$44,204 from \$119,204 to \$75,000. This amendment requests the reduction of \$44,204 from the Governor's budget request of \$119,204 due to lower projected spending (19-DOARICAP4).

Decrease Rhode Island Capital Plan Funds – Pastore Center Demolition project, Page 4, Line 10 by \$125,100 from \$175,000 to \$49,900. This amendment requests the reduction of \$125,100 from the Governor's budget request of \$175,000 due to lower projected spending (19-DOARICAP5).

Decrease Rhode Island Capital Plan Funds – Shepard Building project, Page 4, Line 15 by \$187,100. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$62,900. This amendment requests the reduction of the \$187,100 projected surplus in FY 2019 due to lower projected spending. The Efficiency Commission's Real Estate recommendations include the sale of the Shepard Building in FY 2021 (19-DOARICAP6).

Decrease Rhode Island Capital Plan Funds – Pastore Center Water Tanks and Pipes project, Page 4, Line 17 by \$250,173 from \$365,000 to \$114,827. This amendment requests the reduction of \$250,173 from the Governor's budget request of \$365,000 due to lower projected spending (19-DOARICAP7).

Decrease Rhode Island Capital Plan Funds – Board of Election (Medical Examiner) project, Page 4, Line 21 by \$658,816 from \$670,000 to \$11,184. This amendment requests the reduction of \$658,816 from the Governor's budget request of \$670,000. The



Governor's Budget plan included funding for roof repairs and A&E services to move the Medical Examiner's Office to 50 Branch Avenue. The Efficiency Commission's Real Estate recommendation is to sell 50 Branch Avenue. The project was closed with the surplus stated (19-DOARICAP8).

Decrease Rhode Island Capital Plan Funds – DoIT Operations System Renovations, Page 4, Line 26 by \$650,000 from \$850,000 to \$200,000. The decrease of \$650,000 is requested due to the cancelation of the generator project. The remaining funds are being utilized to transfer servers located at the Center General to 50 Service Avenue (19-DOARICAP9).

Decrease Rhode Island Capital Plan Funds – BHDDH DD & Community Homes - Fire Code project, Page 4, Line 30 by \$1,250,000 from \$2,450,000 to \$1,200,000. This amendment requests moving the \$1,250,000 projected surplus from FY 2019 to FY 2020 for projects anticipated to be completed in FY 2020 (19-DOARICAP10).

Decrease Rhode Island Capital Plan Funds – BHDDH DD Regional Facilities – Asset Protection project, Page 4, Line 32 by \$50,000 from \$500,000 to \$450,000. This amendment requests moving the \$50,000 projected surplus from FY 2019 to FY 2020 for projects anticipated to be completed in FY 2020 (19-DOARICAP11).

Decrease Rhode Island Capital Plan Funds – BHDDH DD Group Homes project, Page 4, Line 33 by \$200,000 from \$1,000,000 to \$800,000. This amendment requests a reduction of \$200,000 in FY 2019 due to lower projected spending (19-DOARICAP12).

Decrease Rhode Island Capital Plan Funds – Hospital Consolidation, Page 4, Line 34 by \$702,000 from \$2,202,000 to \$1,500,000. This amendment moves the \$702,000 projected surplus from FY 2019 to FY 2020 for the Hospital Consolidation Project. It is anticipated that the Construction Manager at Risk will be selected by the end of FY 2019, and the construction documents will be bid in July 2019 (19-DOARICAP13).

Decrease Rhode Island Capital Plan Funds – McCoy Stadium project, Page 5, Line 1 by \$81,094 from \$600,000 to \$518,906. This amendment requests the reduction of \$81,094 from the Governor's budget request of \$600,000 due to lower projected spending (19-DOARICAP14).

Decrease Rhode Island Capital Plan Funds – Pastore Center Master Plan project, Page 5, Line 2 by \$2,350,000. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$650,000. The reduction of \$2,350,000 includes the forecasted purchase price and feasibility study of 55 Colorado Avenue totaling \$2,000,000. The Governor's Efficiency Real Estate recommendations include selling this property. The remaining reduction totaling \$350,000 is for the Pastore Master Plan funding. The Purchase Order was cancelled. The multi-year project was forecasted at \$850,000. The remaining balance is reduced in the FY 2020 RICAP Amendment (19-DOARICAP15).



Decrease Rhode Island Capital Plan Funds – Pastore Center Parking project, Page 5, Line 3 by \$109,795 from \$193,040 to \$83,245. This amendment requests the reduction of \$109,795 from the Governor’s budget request of \$193,040. The project was finalized with the surplus stated due to lower projected spending (19-DOARICAP16).

Decrease Rhode Island Capital Plan Funds – South County Capital project, Page 5, Line 4 by \$532,344. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$35,000. This amendment requests a reduction of \$532,344 in FY 2019 and moves it to FY 2020 which will partially offset the \$900,000 required in FY 2020 for the installation of a generator and restroom improvements at the Stedman Center. The projects were deferred until the Governor’s Efficiency Commission Real Estate recommendations were presented. This building was not recommended for sale, and the transfer of funds to FY 2020 will initiate asset protection projects at this facility (19-DOARICAP17).

Decrease Rhode Island Capital Plan Funds – Virks Building Renovations project, Page 5, Line 5 by \$757,670 from \$300,000 to (\$457,670). This amendment requests the reduction of \$757,670 from the Governor’s budget request of \$300,000. The net change results in a credit balance of \$457,670. The credit balance is due to an account payable being established and payments for the same expenses processed during the FY 2018 closing; therefore, overstating the FY 2018 ending expenditures. The accounts payable was reversed in FY 2019, and the remaining obligations for this project is the final payment of retainage (19-DOARICAP18).

Decrease Rhode Island Capital Plan Funds – Capitol Hill Campus project, Page 5, Line 6 by \$1,175,624 When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$3,200,000. This amendment request moves \$611,894 of the \$1,175,624 projected surplus from FY 2019 to FY 2020 for projects projected to be completed in FY 2020 including elevator replacement, campus wide HVAC work and Cannon Building electrical replacement (19-DOARICAP19).

Decrease Rhode Island Capital Plan Funds – Pastore Center Campus project, Page 5, Line 8 by \$4,295,112 from \$13,295,112 to \$9,000,000. This amendment requests moving the projected surplus of \$4,295,112 from FY 2019 to FY 2020 to complete the Barry Simpson renovations which will be completed in FY 2020 (19-DOARICAP20).

Increase Rhode Island Capital Plan Funds – BHDDH - Substance Abuse Asset Protection, Page 5, Insert following Line 8 by \$233,413 from \$0 to \$233,413. The Governor’s Recommend Budget included the transfer of certain RICAP accounts connected to capital projects managed by DCAMM from the BHDDH budget to the DOA budget under DCAMM. The eleven state-owned substance abuse properties are managed through DCAMM, and BHDDH is requesting that this account move to DOA (19-DOARICAP21).



**Department of Business Regulation**

Decrease Rhode Island Capital Plan Funds – Fire Academy project, Page 7, Line 21 by \$185,160 from \$489,717 to \$304,557. This amendment moves requests moving the \$185,160 projected surplus from FY 2019 to FY 2020 to support the completion of the cold storage facility at the Fire Training Academy in Exeter (19-DBRRICAP1).

**Department of Children Youth and Families**

Decrease Rhode Island Capital Plan Funds – Rhode Island Training School Generator project, Page 15, Line 3 by \$185,000 from \$225,000 to \$40,000. This amendment request moves the \$185,000 projected surplus from FY 2019 to FY 2020 to support the completion of the generator project (19-DCYFRICAP1).

**Department of Behavioral Healthcare, Developmental Disabilities and Hospitals**

Increase Rhode Island Capital Plan Funds – DD Private Waiver Fire Code project, Page 19, Line 9 by \$1,748,533 from \$0 to \$1,748,533. The aggregate questioned costs for Single Audit findings: 2008-92; 2009-74; 2010-76; and 2011-79 relating to the Rhode Island Department of Behavioral Healthcare, Developmental Disabilities and Hospitals' (BHDDH) utilization of federal funds to match the State cost of fire code upgrades at privately-operated facilities for developmental disabled adult clients totaled \$1,748,533. The Department of Health and Human Services denied the Department's appeal regarding the Single Audit findings and returned the federal funds to The Department of Health and Human Service. The requested amendment is to fund the reimbursement from the Department's RICAP account consistent to where the original State match originated (19-BHDDHRICAP1).

Decrease Rhode Island Capital Plan Funds – Substance Abuse Asset Protection project, Page 19, Line 31 by \$233,413 from \$233,413 to \$0. The Governor's Recommend Budget included the transfer of certain RICAP accounts connected to capital projects managed by DCAMM from the BHDDH budget to the DOA budget under DCAMM. The eleven state-owned substance abuse properties are managed through DCAMM, and the Department is requesting that this account move to DOA (19-BHDDHRICAP2)

**Higher Education**

***Office of Post-Secondary Commissioner***

Decrease Rhode Island Capital Plan Funds – Higher Education Centers project, Page 23, Line 27 by \$1,800,000 from \$2,000,000 to \$200,000. This amendment requests moving the \$1.8 million projected surplus from FY 2019 to FY 2020 for project implementation in FY 2020 (19-OPCRICAP1).

***University of Rhode Island***

Decrease Rhode Island Capital Plan Funds – Biological Resources Lab project, Page 24, Line 24 by \$3,491,756. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$1,750,000. This amendment requests moving \$2,855,486 of the \$3,491,756 projected surplus from FY 2019 to FY 2020 for project implementation in FY 2020. The requested amount from the FY 2019 projected surplus



was identified by the University of Rhode Island to complete the project in FY 2020 (19-URIRICAP1).

***Rhode Island College***

Decrease Rhode Island Capital Plan Funds – Master Plan Advanced Planning project, Page 25, Line 14 by \$150,000. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$0. This amendment requests moving the \$150,000 in the Governor’s FY 2019 Budget request to FY 2020 for the Master Plan at the Henry Barnard School (19-RICRICAP1).

**Department of Corrections**

Decrease Rhode Island Capital Plan Funds – Asset Protection project, Page 28, Line 4 by \$1,699,328. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$10,435,012. This amendment moves the projected surplus from FY 2019 to FY 2020 for projects continuing in FY 2020, specifically the \$26.0 million multi-year award for the Medium Security Project (19-DOCRICAP1).

**Judiciary**

Decrease Rhode Island Capital Plan Funds – Noel Shelled Courtroom Buildout project, Page 29, Line 19 by \$2,176,073 from \$4,476,073 to \$2,300,000. This amendment moves the Judiciary’s projected surplus from FY 2019 to FY 2020 to complete the project in FY 2020 (19-JUDRICAP1).

**Military Staff**

Decrease Rhode Island Capital Plan Funds – Armory of Mounted Command Roof Replacement project, Page 30, Insert following Line 16 by \$536,573 from \$718,375 to \$181,800. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete the project in FY 2020. The project was delayed due to federal shortfall and scope change (19-MILRICAP1).

Decrease Rhode Island Capital Plan Funds – Bristol Readiness Center project, Page 30, Line 18 by \$125,000 from \$125,000 to \$0. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete the project in FY 2020. The request for proposal is in the Division of Purchasing (19-MILRICAP2).

Decrease Rhode Island Capital Plan Funds – Joint Force Headquarters project, Page 30, Line 20 by \$357,896 from \$6,559,556 to \$6,201,660. This amendment moves the projected surplus from FY 2019 to FY 2020. The revised forecast is based upon the projected billing of the project (19-MILRICAP3).

**Department of Public Safety**

Decrease Rhode Island Capital Plan Funds – DPS Asset Protection projects, Page 31, Line 10 by \$124,157 from \$766,586 to \$642,429. This amendment requests the reduction of \$124,157 from the Governor’s budget request of \$766,586 due to lower projected spending (19-DPSRICAP1).



Decrease Rhode Island Capital Plan Funds – Training Academy Upgrades project, Page 31, Line 11 by \$375,879 from \$733,815 to \$357,936. This amendment requests the reduction of \$375,879 from the Governor’s budget request of \$733,815 due to lower projected spending (19-DPSRICAP2).

**Department of Environmental Management**

Decrease Rhode Island Capital Plan Funds – Blackstone Valley Park Improvements project, Page 32, Line 19 by \$500,000 from \$885,740 to \$385,740. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete the Blackstone Valley Bike Path in FY 2020 (19-DEMERICAP1).

Decrease Rhode Island Capital Plan Funds – Recreational Facilities Improvement project, Page 32, Line 23 from by \$1,000,000 from \$3,100,000 to \$2,100,000. This amendment moves the projected \$1.0 million surplus from FY 2019 to FY 2021 (\$500,000) and FY 2023 (\$500,000) (19-DEMERICAP2).

Decrease Rhode Island Capital Plan Funds – Galilee Piers Upgrade project, Page 32, Line 24. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$210,000. This amendment moves the projected surplus from FY 2019 to FY 2020. The funding will provide match for a \$1.6 million federal grant for reconstruction of three commercial piers and bulkheads in Galilee (19-DEMERICAP3).

Decrease Rhode Island Capital Plan Funds – State Recreation Building Demolition project, Page 32, Line 32 by \$154,322 from \$189,202 to \$34,880. This amendment moves the projected surplus from FY 2019 to FY 2020 (19-DEMERICAP5).

Decrease Rhode Island Capital Plan Funds – Newport Pier Upgrade project, Page 32, Line 34 by \$66,372 from \$193,750 to \$127,378. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete the project under a revised schedule (19-DEMERICAP4).

**Department of Transportation**

Decrease Rhode Island Capital Plan Funds – Maintenance Facility Improvements project, Page 34, Line 26 by \$519,349 from \$612,624 to \$93,275. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete scheduled roof replacement at East Providence garage in FY 2020, and DOT’s share of Energy Efficiency Projects sponsored by the Office of Energy Resources (19-DOTRICAP1).

Decrease Rhode Island Capital Plan Funds – Salt Storage Facilities project, Page 34, Line 27 by \$170,775. When combined with the February 15 amendment to this line item, this amendment yields a line item total of \$929,225. This amendment moves the projected surplus from FY 2019 to FY 2020 to complete the Portsmouth facility prior to FY 2020 winter season (19-DOTRICAP2).

Decrease Rhode Island Capital Plan Funds – Train Station Maintenance and Repairs project, Page 32, Line 31 by \$247,463 from \$502,323 to \$254,860. This amendment moves



the projected surplus from FY 2019 to FY 2020 for the Westerly Station window replacement project (19-DOTRICAP3).
