Amendments to Article 12 of the FY 2020 Appropriations Act

(19-H-5151)

The Governor requests that the amended Article 12 entitled "Relating to Economic Development" submitted on March 12, 2019 be further amended as follows.

Section 1 on the Quonset Development Corporation is amended to correct a drafting oversight that erroneously labeled new section (j) as (d) in 42-64.10-6 and should be corrected as follows:

Page 292, Line 16

Strike "(d)" and replace with "(j)"

Section 2 on the Quonset Development Corporation contains erroneous cross-references due to the drafting error in section 1. Due to the mislabeling of section 42-64.10-6 (j) under Section 1, Section 2 contains erroneous cross-references to "(d)" instead of "(j)" and should be corrected as follows:

Page 292, line 29 and on page

Strike "(d)" and replace with "(j)"

293, in lines 26, 32, and 34

Section 3 on the Rebuild Rhode Island Tax Credit includes the addition of a new definition of "Manufacturer" with subparts labeled as "a" and "b". For consistency with the existing definitional section, the subparts should be changed to romanettes "i" and "ii". The correction should be as follows:

Section 3 on the Rebuild Rhode Island Tax Credit includes the addition of a new definition and all definitions following the insertion of the new definition number "(15)" are re-numbered. Section 3 contains an error in the renumbering and should be corrected as follows:

Section 4 on the Rebuild Rhode Island Tax Credit is amended to correct a drafting oversight which resulted in a grammatical error and should be corrected as follows:

12	Page 299 on line 2	Strike the word "involved" and replace with "involve"

Section 4 on the Rebuild Rhode Island Tax Credit is amended to correct a drafting oversight which erroneously inserted extraneous language into the tax credit requirements and should be corrected as follows:

12	Page 299, Lines 10-13	Strike the words "who have received the notice referenced
		in subsection (d) above and who may be eligible" and after

In section 5 on the Rebuild Rhode Island Tax Credit, a cross-reference is updated to accommodate the addition of new definitions in Section 4. The strike-through of outdated cross-references erroneously encompasses sections that should be retained. Section 5 should include a cross-reference that reads "42-64.20-5 (b), (f), (g), (h), (i), (j), (q), (r), and (s)" on page 302, in line 30; and section 5 should be corrected as follows:

Section 5 on the Rebuild Rhode Island Tax Credit is amended to correct a drafting oversight which omitted the word "certified" to clarify the types of historic structures eligible to receive technical assistance and is corrected as follows:

Section 20 was not assigned a chapter title during drafting. The title of this chapter should read as "The State and Local Partnership Act" and section 20 should be corrected as follows:

12	Page 307, line 29	Strike the words "it is hereby enacted as follows:" and

insert: Title 42 of the General Laws entitled "STATE AFFAIRS AND GOVERNMENT" is hereby amended by adding

THE STATE AND LOCAL PARTNERSHIP ACT

Section 20 was not assigned a chapter title during drafting and consistent the amendment to add the chapter title, the short title set forth in § 42-64.33-2 should read "The State and Local Partnership Act". Section 20 should be corrected as follows:

Section 20 is amended to correct a drafting oversight which erroneously creates a cross-reference to an incorrect section in § 42-64.33-5(b). The cross-reference should be corrected as follows:

Section 20 is amended to correct a drafting oversight in delineating the appointment and voting powers of the chairperson of the State and Local Partnership Council and should be corrected as follows:

12	Page 313, Line 23-25	Add "appointed by the governor" after "(9) members" in
		the first sentence. Strike the second sentence "The

*		eight (8) members appointed by the governor."
12	Page 313, line 29	Strike "two (2)" and insert "three (3)"

Section 25 is amended to correct a drafting oversight which erroneously omitted the word "this" in creating reporting requirements for the Commerce Corporation and taxpayers receiving the tax credits. The omission should be corrected as follows:

Page 340, Lines 10 and 13 Insert "this" before the word "section"

Section 26 includes the addition of a new definition "11" and all subsequent definitions are renumbered. Section 26 contains an error in the renumbering and should be corrected as follows

Page 342, Line 14 Insert strike through "4" after "15"

Section 27 inadvertently excluded the word "new" when referring to full-time jobs eligible for qualified jobs tax credits. This should be corrected as follows:

Page 343, Line 14 Insert "new" before "full-time job"
