Subject:	New Article for the FY 2020 Appropriations Act (19-H-5151)

The Governor requests that an additional article, entitled "Relating to Statewide Planning Program", be submitted alongside the other articles submitted on January 17, 2019. This article amends current statute to modify the composition of the State Planning Council, the state's sole Metropolitan Planning Organization, ensuring broader participation by communities and underrepresented groups. The article also codifies the Transportation Advisory Committee (TAC) as one of three principal advisory committees of the Metropolitan Planning Organization.

As part of the Federal Highway Administration (FHWA)/Federal Transit Administration (FTA) Recertification Review of the Rhode Island Metropolitan Planning Organization in Spring 2018, one of the corrective actions required was the inclusion of more elected officials on the MPO itself. Currently, membership includes six public members, four of whom are undefined. After a series of State Planning Council and Division of Planning staff meetings, changes to SPC membership were developed to include membership of municipalities of varying sizes, along with more specifics as to additional public members.

In accordance with these findings and recommendations, the Governor recommends the following changes to the State Planning Council's membership structure:

(1) Removing the State Budget Officer from the State Planning Council membership.

(2) Removing one official of local government who shall be appointed by the Governor from a list of not less than three submitted by the Rhode Island League of Cities and Towns.

(3) Adding three chief elected officials of cities and towns, appointed by the Governor after consultation with the Rhode Island League of Cities and Towns, one of which shall be from a community with a population greater than 40,000 people, one of which shall be

from a community of between 20,000 and 40,000 people, and one of which shall be from a community with fewer than 20,000 people.

(4) Changing the number of public members from six to four, maintaining the existing requirement for one employer with fewer than fifty employees and one employer with greater than fifty employees, but adding a requirement for both a representative of a professional planning or engineering organization in Rhode Island as well as a representative of a chamber of commerce or economic development organization.

(5) Expanding representation on the council to include environmental justice organizations.

(6) Adding the Director of the Rhode Island Emergency Management Agency to the State Planning Council.

	3	SECTION 1. Section 42-11-10 of the General Laws in Chapter 42-11 entitled "Department of
	4	Administration" is hereby amended to read as follows:

	6	(a) Findings. The general assembly finds that the people of this state have a fundamental interest in
	7	the orderly development of the state; the state has a positive interest and demonstrated need for
	8	establishment of a comprehensive, strategic state planning process and the preparation, maintenance,
	9	and implementation of plans for the physical, economic, and social development of the state; the
1	.0	continued growth and development of the state presents problems that cannot be met by the cities and
1	.1	towns individually and that require effective planning by the state; and state and local plans and
1	.2	programs must be properly coordinated with the planning requirements and programs of the federal
1	.3	government.
1	.4	(b) Establishment of statewide planning program.
1	.5	(1) A statewide planning program is hereby established to prepare, adopt, and amend strategic plans
1	.6	for the physical, economic, and social development of the state and to recommend these to the
1	7	governor, the general assembly, and all others concerned.
1	.8	(2) All strategic planning, as defined in subsection (c) of this section, undertaken by all departments
1	9	and agencies of the executive branch unless specifically exempted, shall be conducted by or under the
2	0	supervision of the statewide planning program. The statewide planning program shall consist of a state
2	1	planning council, and the division of statewide planning, which shall be a division within the
2	2	department of administration.
2	3	(c) Strategic planning. Strategic planning includes the following activities:
2	4	(1) Establishing or identifying general goals.
2	5	(2) Refining or detailing these goals and identifying relationships between them.

2 (4) Preparing long-range or system plans or comprehensive programs that carry out the policies and

5 goals, objectives, and policies, and with long-range or system plans or comprehensive programs
6 where applicable, and that establish measurable, intermediate steps toward their accomplishment of
7 the goals, objectives, policies, and/or long-range system plans.

8 (6) Monitoring the planning of specific projects and designing of specific programs of short duration
9 by the operating departments, other agencies of the executive branch, and political subdivisions of the
10 state to ensure that these are consistent with, and carry out the intent of, applicable strategic plans.

11 (7) Reviewing the execution of strategic plans, and the results obtained, and making revisions

12 necessary to achieve established goals.

(d) *State guide plan.* Components of strategic plans prepared and adopted in accordance with this
section may be designated as elements of the state guide plan. The state guide plan shall be comprised

15 of functional elements or plans dealing with land use; physical development and environmental

16 concerns; economic development; housing production; energy supply, including the development of

17 renewable energy resources in Rhode Island, and energy access, use, and conservation; human

18 services; <u>climate change and resiliency</u>, and other factors necessary to accomplish the objective of this

19 section. The state guide plan shall be a means for centralizing, integrating, and monitoring long-range

20 goals, policies, plans, and implementation activities related thereto. State agencies concerned with

specific subject areas, local governments, and the public shall participate in the state guide planning

22 process, which shall be closely coordinated with the budgeting process.

(e) *Membership of state planning council*. The state planning council shall consist of the following
 members:

7	issued by the state planning council under this section. The records shall be open to the public.
8	(3) The division of statewide planning shall manage and administer the Rhode Island geographic
9	information system of land-related resources, and shall coordinate these efforts with other state
10	departments and agencies, including the University of Rhode Island, which shall provide technical
11	support and assistance in the development and maintenance of the system and its associated data
12	base.
13	(4) The division of statewide planning shall coordinate and oversee the provision of technical
14	assistance to political subdivisions of the state in preparing and implementing plans to accomplish
15	the purposes, goals, objectives, policies, and/or standards of applicable elements of the state guide
16	plan and shall make available to cities and towns data and guidelines that may be used in preparing
17	comprehensive plans and elements thereof and in evaluating comprehensive plans and elements
18	thereby.
