#### **REPRESENTATIVE FOGARTY ST. PATRICK'S DAY REMARKS**

Any public celebration of St. Patrick's Day eventually gets around to talking about Irish persecution — first by the British, and then the discrimination faced by Irish immigrants when they first came to these shores in the 19<sup>th</sup> Century. And in truth, the story of the Irish resonates particularly strongly today as the national debate on immigration has reached fever pitch.

I'm proud that my colleagues have worked so tirelessly over the past few years to welcome and make life fairer for the newest members of our society, including driving privilege cards for undocumented residents, in-state tuition rates for immigrants, or stopping employers from using immigration status against whistleblowers.

These things were the decisions of informed lawmakers, many of whom are immigrants themselves. But I like to think that the story of the Irish was a sobering lesson that helped inform many of those decisions — especially for those of us with Irish ancestry who grew up hearing the tales of Irish persecution.

There have been hundreds of lawmakers of Irish descent in Rhode Island over the years and I'm proud to be one of them. It wasn't always that way, though. When the first influx of Irish began to arrive in the 1820s, they were not exactly welcomed with open arms. Here in Rhode Island, as everywhere else, they were spurned as lower-class menials, and "No Irish Need Apply" signs were not uncommon.

The last person executed for a crime in this state, John Gordon, was a poster boy for discrimination. Convicted in 1845 of killing wealthy industrialist Amasa Sprague, it was pretty obvious even at the time, that the only thing he was guilty of was being Irish. The judge even told the jurors to give greater weight to Yankee witnesses than Irish witnesses. This was a century before Italians Sacco and Vanzetti would face similar discrimination that led to their execution in Massachusetts.

Ten years later, anti-Irish sentiment still dominated this very chamber, and even the governor, William Hoppin, was a leader of the Know-Nothing party. Officially called the "American Party," it was an anti-Catholic, anti-Irish organization that was very influential in Rhode Island politics. They were called the "Know Nothings' because when asked about party business, its members were instructed to say, "I know nothing." Governor Hoppin spread a rumor about an armed Catholic conspiracy in Rhode Island, using the rumor to justify providing uniforms and weapons to form the so-called Guards of Liberty, a military unit whose sole purpose was to harass and beat Irish Catholics.

(Mr. Speaker, I know that it's traditionally frowned upon to bad-mouth a governor in this chamber, but I think enough time has gone by since 1854. There must be some sort of statute of limitations on that)

But Rhode Island attitudes toward the Irish changed in the Civil War, when Irish-Americans accounted for more than half of the Union Army. And the contributions of Irish-Americans in ending slavery and preserving the union were extraordinary. Two Rhode Island Irishmen, John Corcoran and James Welsh were recipients of the newly created Congressional Medal of Honor for their wartime heroism.

Speaking of the Medal of Honor, did you know that it's been given to 257 native-born Irish? That's twice as many as any other ethnic group. When it comes to bravery and heroism, Irish-Americans always had a huge surplus to give their country.

But Irish contributions go far beyond warfare. Just look at the arts. Take music for instance. When you think of patriotic American music, you need look no further than Rhode Island's own Irish-American George M. Cohan, who was born in Providence on the 4<sup>th</sup> of July. (Actually, he was born on the 3<sup>rd</sup> of July, but sometimes the Irish are given to exaggeration, and that's OK). He was the one who wrote "Yankee Doodle Dandy," "You're a Grand Old Flag," and "Over There." There's a nice statue of him waving his hat at Fox Point, and he's the only performer who has a statue in New York's Times Square.

Ireland is a small nation. Its population is only about four times the size of Rhode Island. Yet from this small country came a huge impact on the history of this state, this country and the whole world. When you look beyond the leprechaun and the shillelagh and see the real culture of Ireland — its art, its literature, its science and engineering — those things that have been propounded by the sons and daughters of the Emerald Isle, and their grandsons and granddaughters in America, you realize that the collective whole of the Irish people have made the world a better place in ways that can never be calculated.

And we need to remember that when we try to make our state and country a little more welcoming to the newest immigrant groups that enrich our society and make the world a better place. And maybe we can make it just a little easier for them than our 19<sup>th</sup> Century counterparts did for the Irish. So, adjust your shamrocks, raise a pint of Guinness and drink a toast to the Irish in America — and be proud and glad of the fact that without the Irish, the American experiment would have died in its infancy.

Fortunately, we'll always be around to get the country out of a jam when things get rough.
