The Rhode Island Press Association recently and rightfully inducted Marta into the Rhode Island Journalism Hall of Fame. This tremendous honor recognizes her lifelong visionary leadership, dedication to storytelling, and lasting contributions to our state that amplify voices and preserve the stories of Rhode Island's Latinx community.

A native of El Paso, Texas, and a proud Providence College and George Washington University graduate, Marta has spent decades in public service, journalism, and cultural preservation. Her work is rooted in community and history, serving as the first director of the Hispanic Social Services Association, which became the Center for Hispanic Policy and Advocacy under her leadership. In 1988, she founded the Hispanic Heritage Committee, which evolved into Rhode Island Latino Arts, a vital organization she continues to lead as Executive Director.

In 1991, she established Nuestras Raíces: The Latino Oral History Project of Rhode Island, capturing the untold stories of Latinx Rhode Islanders. That work culminated in the publication of her book, Latino History in Rhode Island, preserving these narratives for generations to come.

Marta has twice been named a "Person to Watch" by The Providence Journal, served as artist-inresidence at Trinity Repertory Company, and received an honorary degree from her alma mater, Providence College.
