

In recognition of the extraordinary sacrifices made by our nation's heroes, we gather to honor the legacy of Staff Sergeant Christopher Potts, a brave and dedicated Rhode Island National Guardsman who served our country with honor and distinction.

On what would have been his 38th birthday, Staff Sergeant Potts made the ultimate sacrifice. He was tragically killed during an attack by insurgents while manning a traffic-control post in Taji, Iraq — approximately 13 miles north of Baghdad, in the region known as the Sunni Triangle.
