Ruggiero. Senate President Ruggiero was born and raised in North Providence's Fruit Hill neighborhood. He was first elected to the General Assembly at age 31 in 1981 and moved to the Senate four years later, where he served for nearly 44 years as the chamber's most senior member. An old-school Democrat and steadfast advocate for labor, he was instrumental in legalizing sports betting. He fought tirelessly for his constituents and all Rhode Islanders until his passing after a courageous battle with cancer. Today, the Rhode Island General Assembly members come together to pay tribute to his remarkable service and enduring impact on this State House and the community.

REMARKS

Speaker Shekarchi and Chairman Corvese share heartfelt sentiments on behalf of the entire House of Representatives. They were both privileged to call Senate President Dominick J. Ruggiero a colleague, dear friend, and mentor for many years. His steady leadership, deep institutional knowledge, and unwavering commitment to the people of Rhode Island were the hallmarks of a remarkable career. He was the embodiment of old-school values, wise, compassionate, and fiercely dedicated to the mission of the General Assembly and to the betterment of every Rhode Islander.

Over the years, they had the unique opportunity to work closely with him, learn from his example, and benefit from the depth of experience that only he could offer. Whether guiding them through the complexities of legislation or reminding them of the importance of public service with heart and humility, Senate President Ruggiero left an indelible mark on their lives and this state.

Together, they extend their deepest condolences to his family, friends, and colleagues in the Senate. Rhode Island has lost a statesman, and the Rhode Island General Assembly has lost a trusted advisor and beloved friend.
