Support of S2825/H8256, Joint Resolution Making an Appropriation of \$5,000,000 to the Rhode Island Public Transit Authority

To Chair DiPalma and the honorable Members of the Senate Finance Committee:

RIPTA has been chronically underfunded, resulting in service cuts which create hardships for those who don't own a car and depend on RIPTA to get to work, and in undermining the attractiveness of public transportation in Rhode Island in general. Many of us, as we get older, depend on mass transit to get around. We need RIPTA in order to live our lives independently.

We urgently need to fund RIPTA to

- become a modern means to get around in the State, so attractive that RIPTA becomes an alternative to individual (car) transportation, especially for those who can't use a car.
- to implement the Transit Forward RI Master Plan, which was adopted by the State Planning Council on December 10, 2020, as a bold and ambitious plan designed to help make Rhode Island a better and more prosperous place to live, work, and play,
- and to reach the decarbonization mandates of the Act on Climate—which we can't without attractive public transportation.

With this in mind, I support all bills in this years' Legislature that increase funding for RIPTA, including

- S2095, Transportation Investment and Debt Reduction Act of 2011, giving 20% of proceeds in Rhode Island's highway maintenance account to RIPTA,
- **S2825/H8256, Joint Resolution Making an Appropriation of \$5,000,000 to the Rhode Island Public Transit Authority,**
- S2668/H8315, Motor Fuel Sales Tax, with \$0.1175 per gallon, or 29.375 of total proceeds for RIPTA,
- S2092, Rideshare or Transportation Network Company Vehicle Surcharge, with \$ 0.75 per fare for RIPTA,
- S3084, Liability and Computation, creating a restricted receipt account for RIPTA to fund its operations from sales tax collected from rideshare companies,
- S3133, Liability and Computation, creating a restricted receipt account for RIPTA to fund its operations from sales tax collected from rideshare companies.

Please bring the bill to a vote in 2026.

Thank you very much for considering my input, and thank you to Senator McKenney for

introducing this important bill.
