RESOLUTION OF THE Foster Glocester Regional School Committee

WHEREAS, The Foster Glocester Regional School District was created by R.I. Public Laws 1958, Chapter 109, entitled "AN ACT AUTHORIZING THE FORMATION OF A REGIONAL SCHOOL DISTRICT EMBRACING THE TOWNS OF FOSTER AND GLOCESTER" ("Charter"),

And Whereas, Section 8 of said Charter, as amended by Public Laws 1998, chapter 1, states in relevant part:

The regional school district financial meeting shall be held on March 24, 2026 at 8:00 p.m. at the regional school building, or other such location as the regional school committee may publicly designate in advance. Beginning in 1999, the regional school district financial town meeting will be held on the third Tuesday in March each year. Special meetings may be called by vote of the regional district school in accordance with conditions governing town meetings generally prescribed by state law. All voters qualified at the financial town meeting next preceding such regional school district financial meeting and the respective towns of Foster and Glocester shall be eligible to attend and vote at the regional district school financial meeting.


And Whereas, Section 10 of said Charter provides:

At least ten (10) days before the annual regional school district financial meeting at which the budget is to be adopted, the regional district school committee shall hold a public hearing on the proposed budget, at which time any citizen entitled to vote at the regional school district financial meeting may be heard. Notice of the date of such hearing, together with a summary of the proposed budget, accompanied by a statement of the amount necessary to be raised by taxation shall be given at least seven (7) days in advance thereof, by publication once in a newspaper of general circulation within the regional school district and published in the state of Rhode Island.


And Whereas, due to exigent circumstances, the budget hearing scheduled for March 3, 2026, had to be cancelled and rescheduled to March 10, 2026, necessitating the regional school district financial meeting be rescheduled to March 24, 2026

Now therefore it be Resolved, the Foster Gloucester Regional School Committee requests that the General Assembly enact special legislation authorizing the moving of the date of the regional school district financial meeting from the third Tuesday in March, 2026 to March 24, 2026, for this year only.
